






portions of SECTIONS 18 T.26 S. R.3 W.

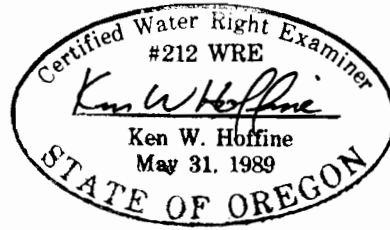
