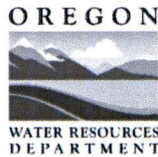

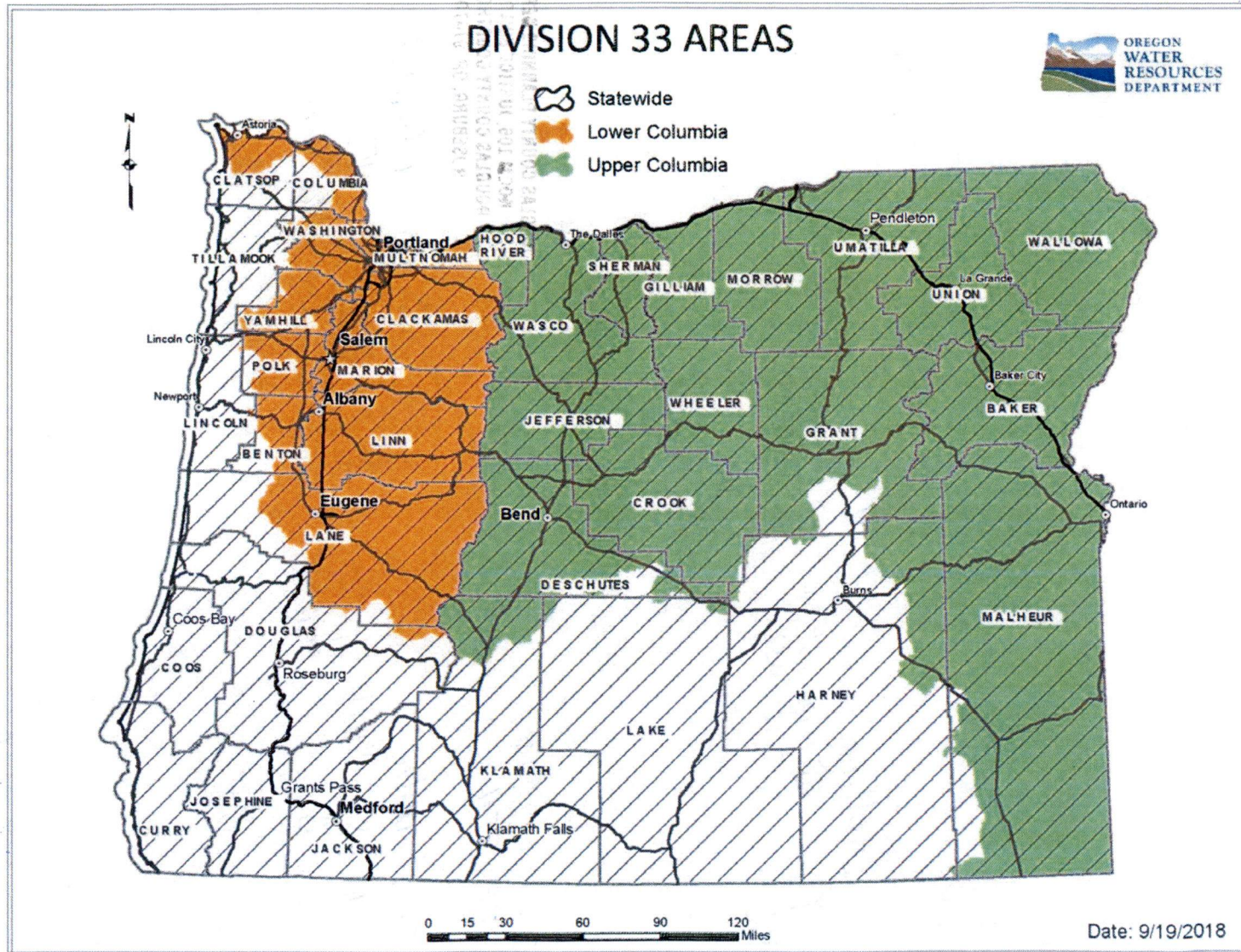

## **Description of Proposed Means of Diversion, Construction, Operation, and Conveyance of Water**

### **Means of Diversion:**

Water will be diverted from the river using a screened intake connected to a pump. The intake will be located at the riverbank and equipped with a fish-screened strainer to prevent the entrainment of fish, debris, and sediment. The intake will be positioned to draw water from below the surface and above the streambed to minimize sediment intake.

### **Diversion Works and Construction:**

The diversion system will consist of a fixed or floating intake assembly with a screened foot valve connected to a pipeline. A centrifugal pump (approximately 1–2 horsepower) will be installed either on a stable platform near the riverbank or as a submersible unit, depending on final installation conditions. All components will be securely anchored to prevent movement during high flows. Construction will involve minimal ground disturbance and will not require channel modification, dams, or impoundments. No excavation within the active stream channel is proposed beyond placement of the intake.

### **Operation of Diversion Works:**

The pump will operate intermittently as needed to supply water for residential domestic use. Water will be pumped uphill approximately 40 feet in elevation to an off-stream storage tank with a maximum storage capacity of approximately 18,000 gallons. Pump operation will be controlled by a float switch or manual control to prevent over-pumping and ensure efficient use of water. Pumping will occur only when water is needed and will not result in continuous diversion.

### **Conveyance of Water:**

Water will be conveyed from the intake to the storage tank through a buried or surface-mounted pipeline (approximately 1½–2 inches in diameter). The pipeline will follow existing ground contours where feasible and will be installed to prevent erosion or damage. From the storage tank, water will be distributed through a pressurized domestic water system for household use. No return flow to the river is proposed.

### **Environmental Protection Measures:**

The intake will be screened in accordance with applicable state and local requirements to protect fish and aquatic life. The diversion system will be maintained regularly to ensure proper function and minimize environmental impact. No chemicals or treatment will occur at the point of diversion.

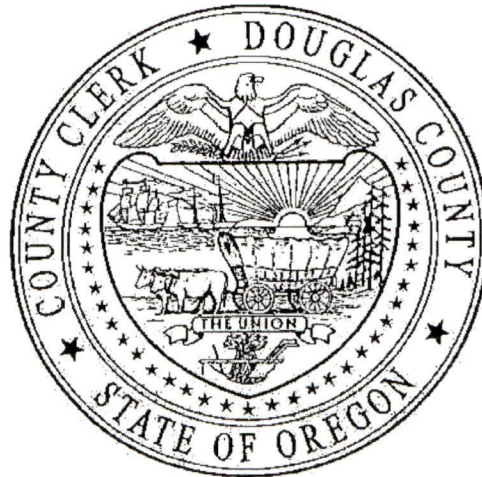

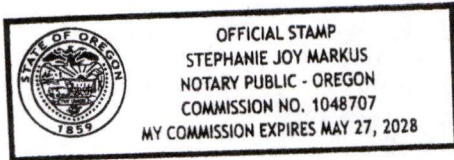
