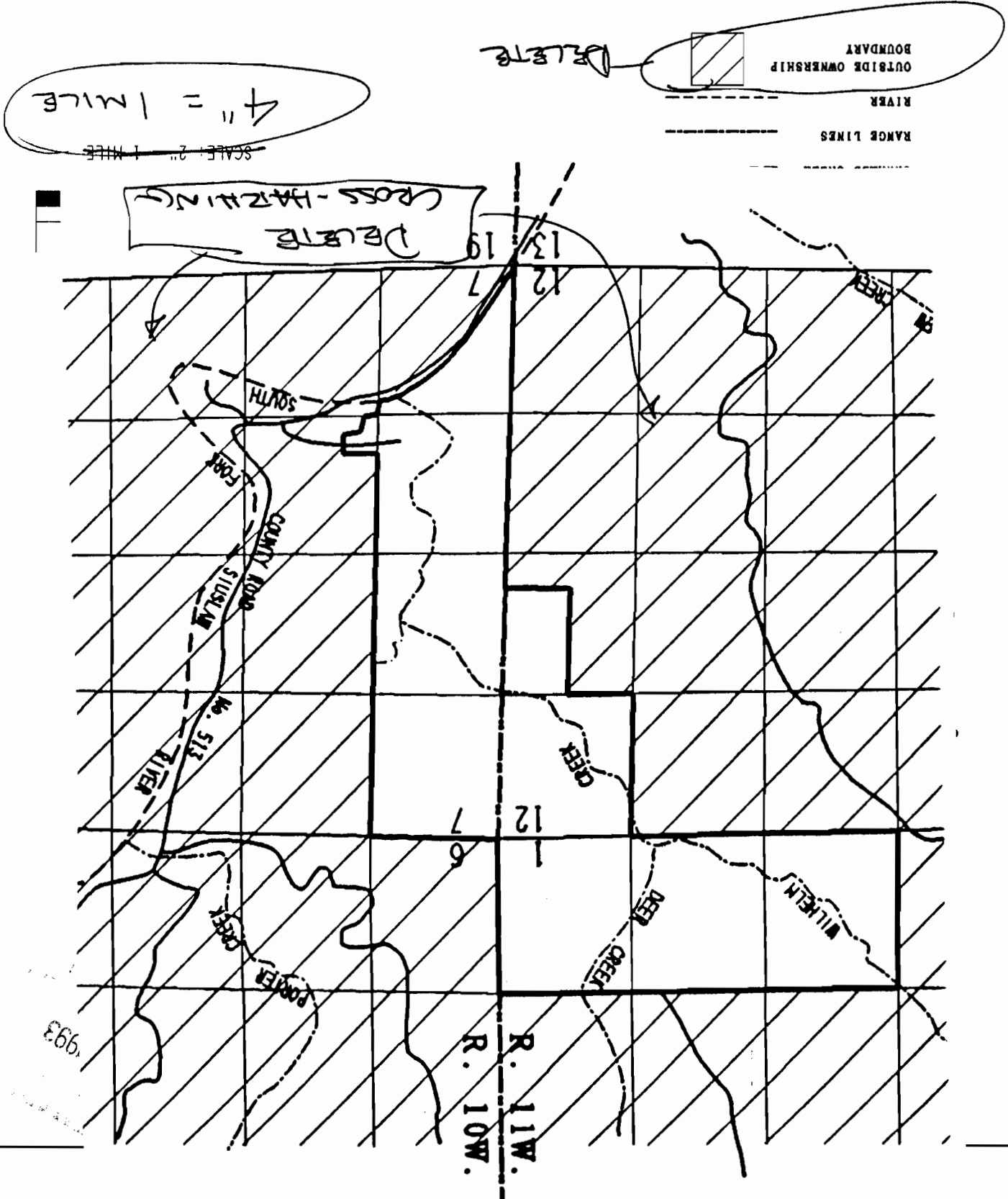


Mr. Knauer,
