TO THE ARTICLES OF INCORPORATION OF  
WILLAMINA LUMBER COMPANY

Pursuant to ORS 60.447, Willamina Lumber Company (the "Corporation") has adopted an amendment to its Articles of Incorporation.

1. The name of the Corporation is Willamina Lumber Company.
2. Article I of the Articles of Incorporation is hereby amended to read in its entirety as follows:


"ARTICLE I

The name of this Corporation is Hampton Lumber Mills, Inc."

3. The amendment was adopted on May 20, 1999.
4. The amendment was duly adopted by the board of directors, and shareholder action was required to adopt the amendment. A total of 1322 shares of Common Stock were outstanding and entitled to vote on the amendment.
5. A total of 1322 shares of Common Stock were voted in favor of the amendment, and no shares of Common Stock were voted against the amendment.
