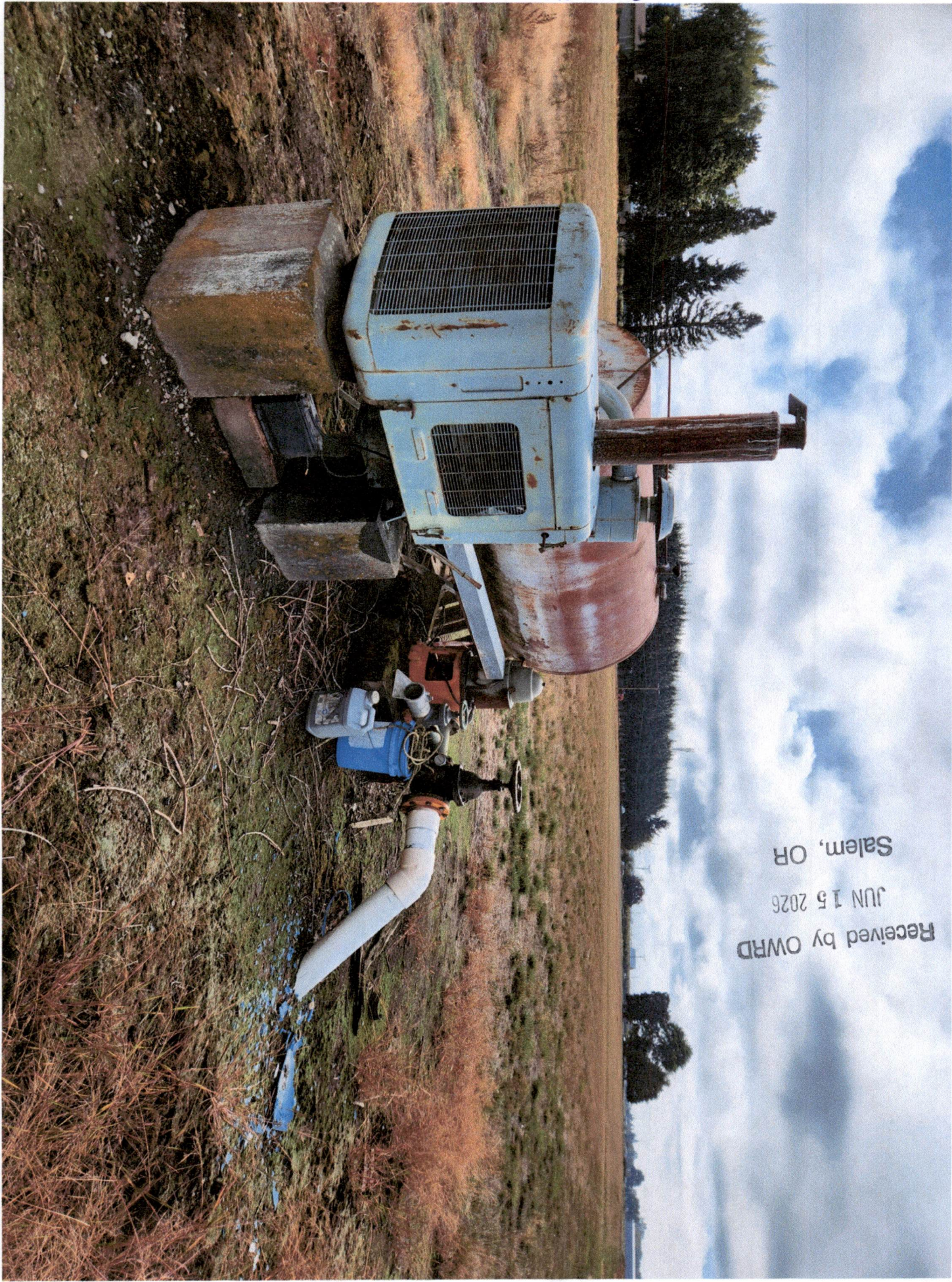

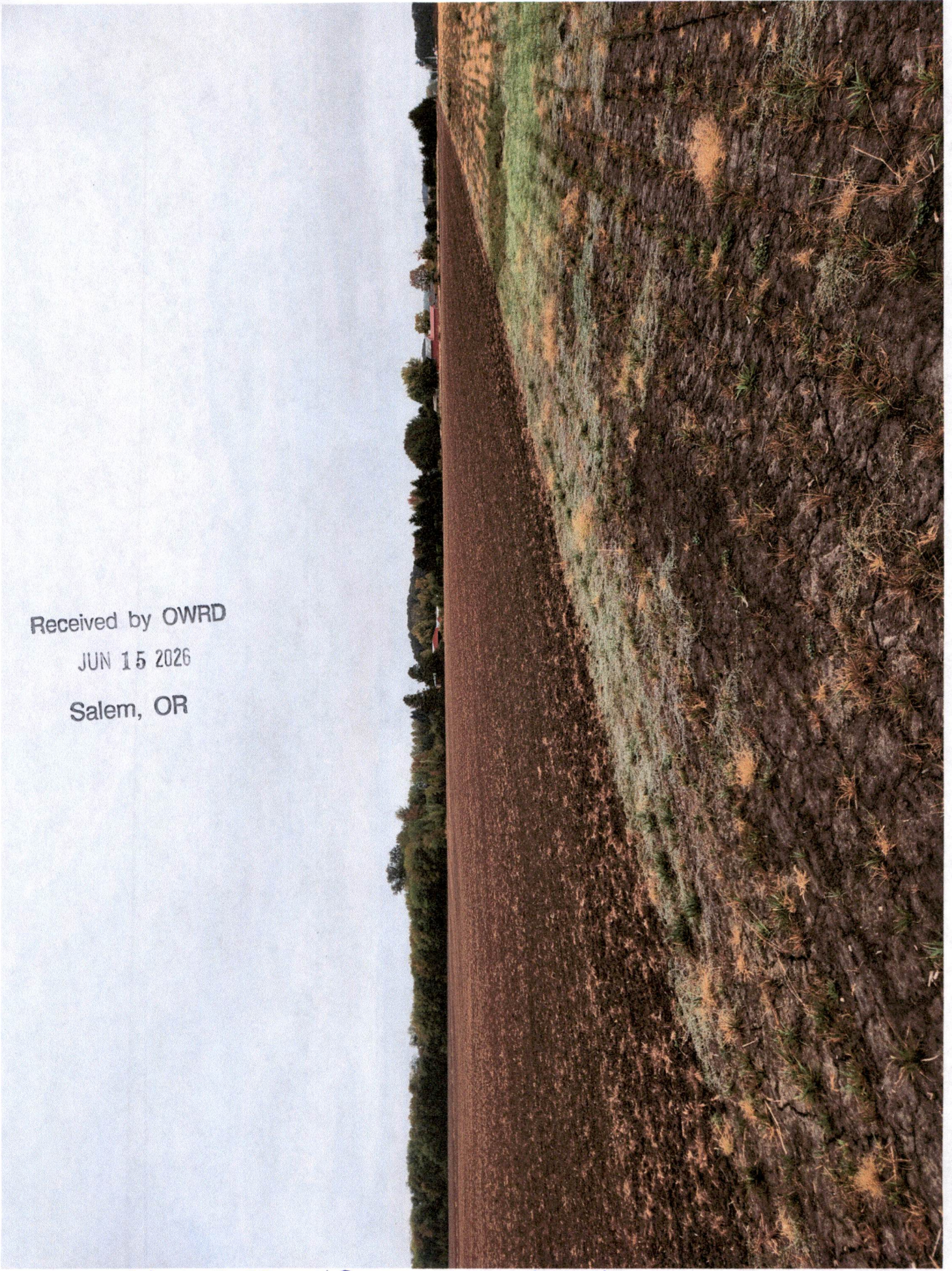


6r055 C0BU 10-3-25 Pump site
