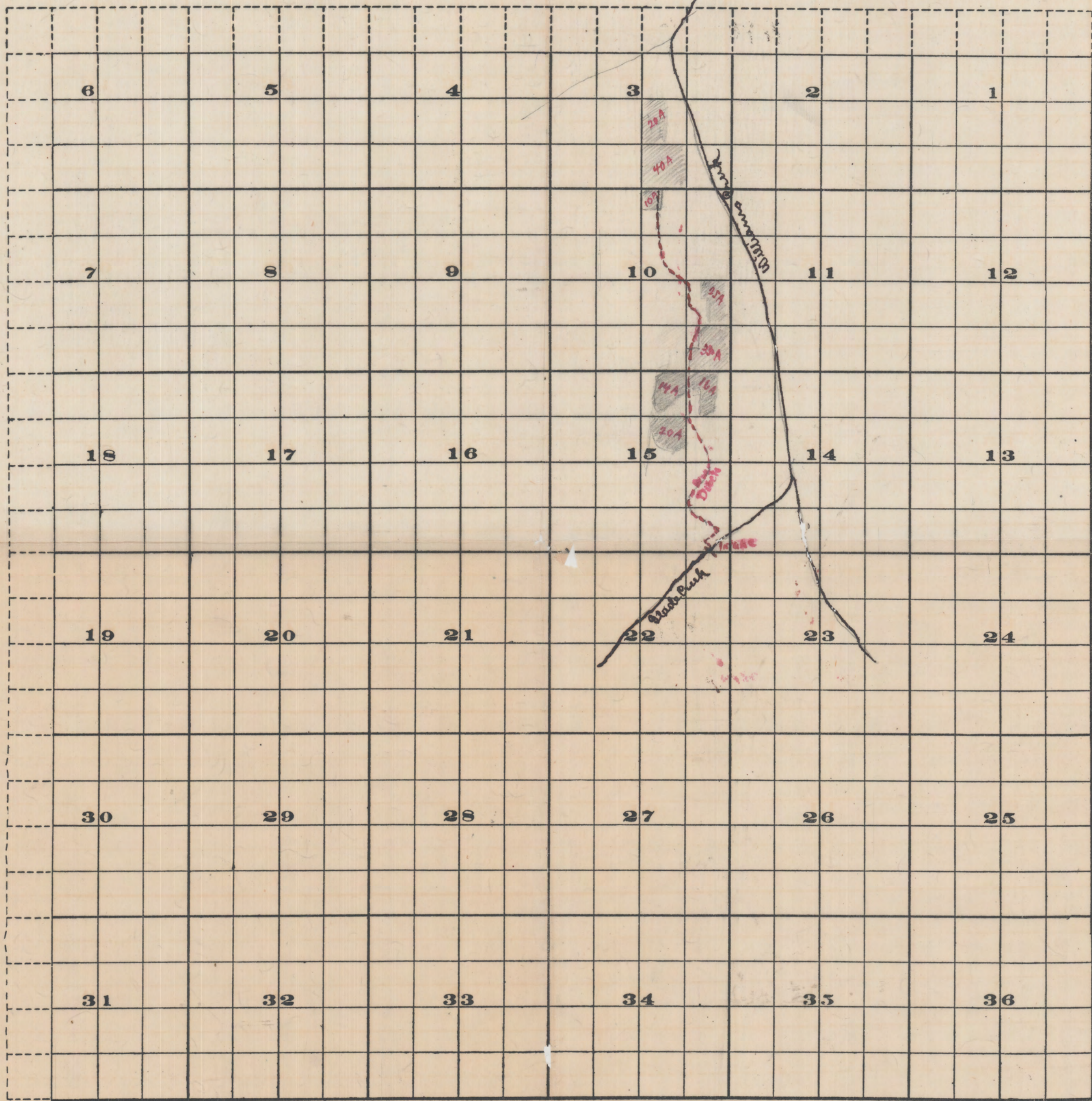

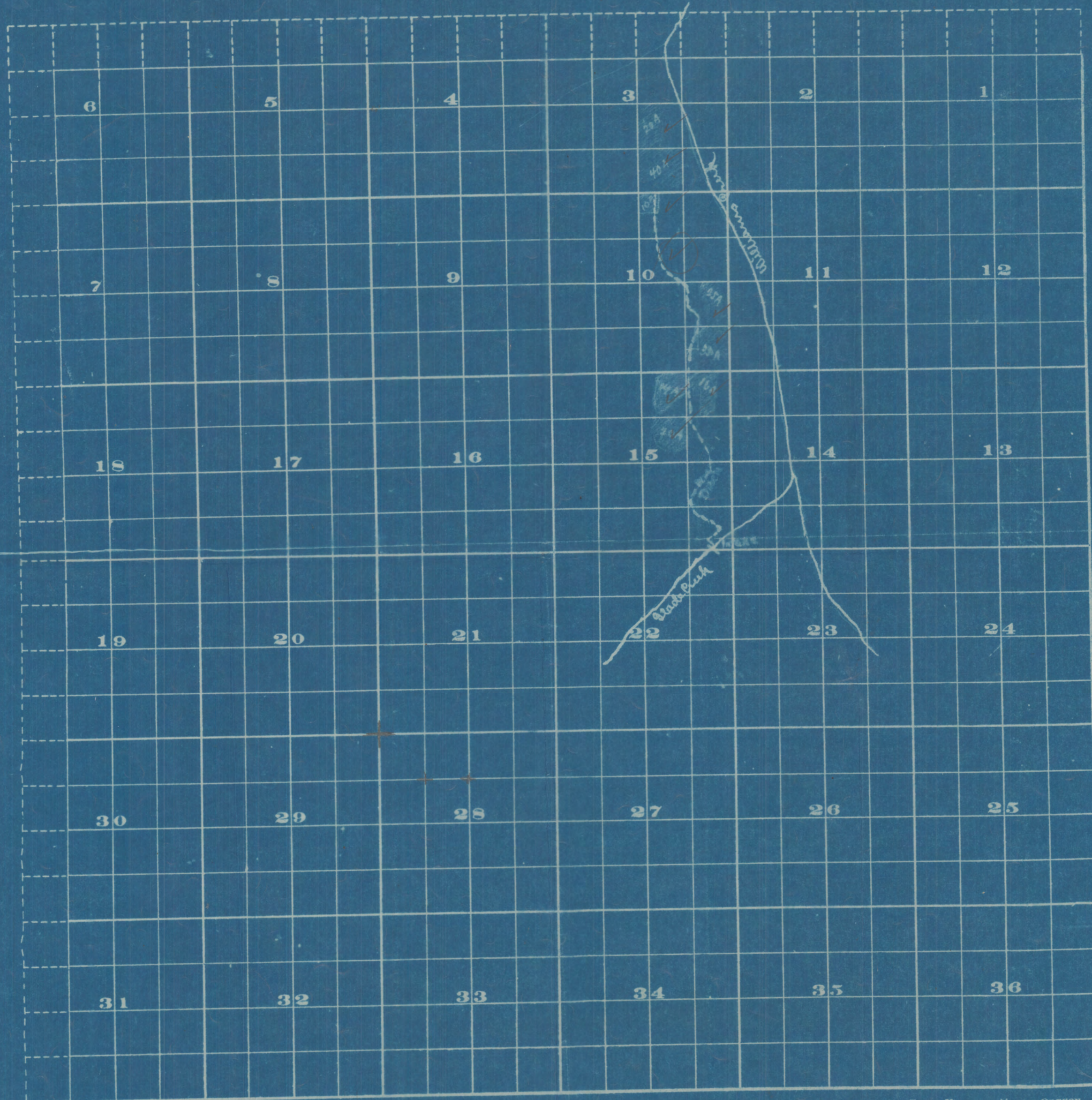

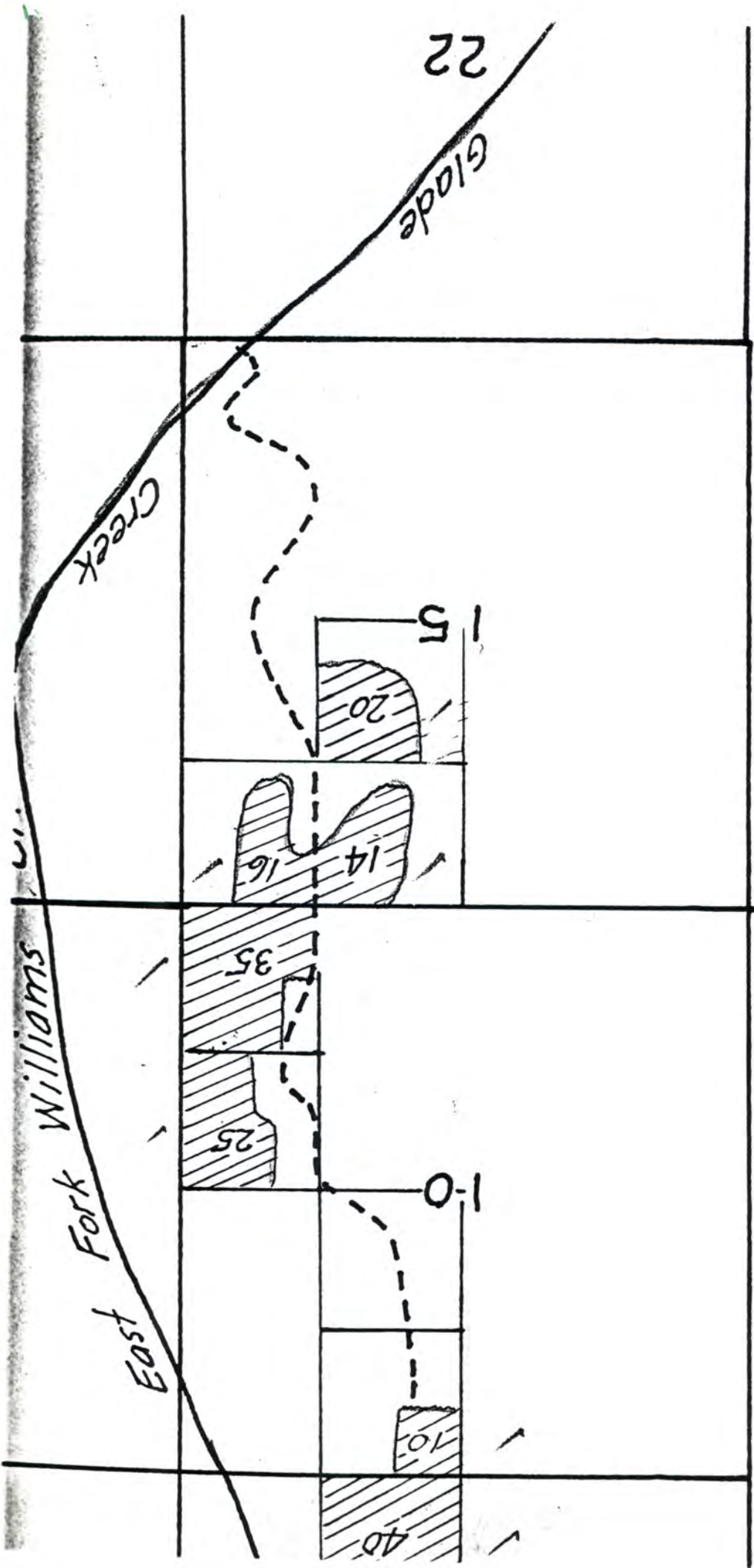


Scale of Feet.

Thank you for your letter of February 16 advising that all lands described in the certificate of water right issued to S. A. McCune, et al, other than those owned by Virgil Berry, are being irrigated, and recommend that a new certificate be issued to Della Morrison for the 60 acres, Section 10, and to Emil Voss for the 50 acres in Section 15. 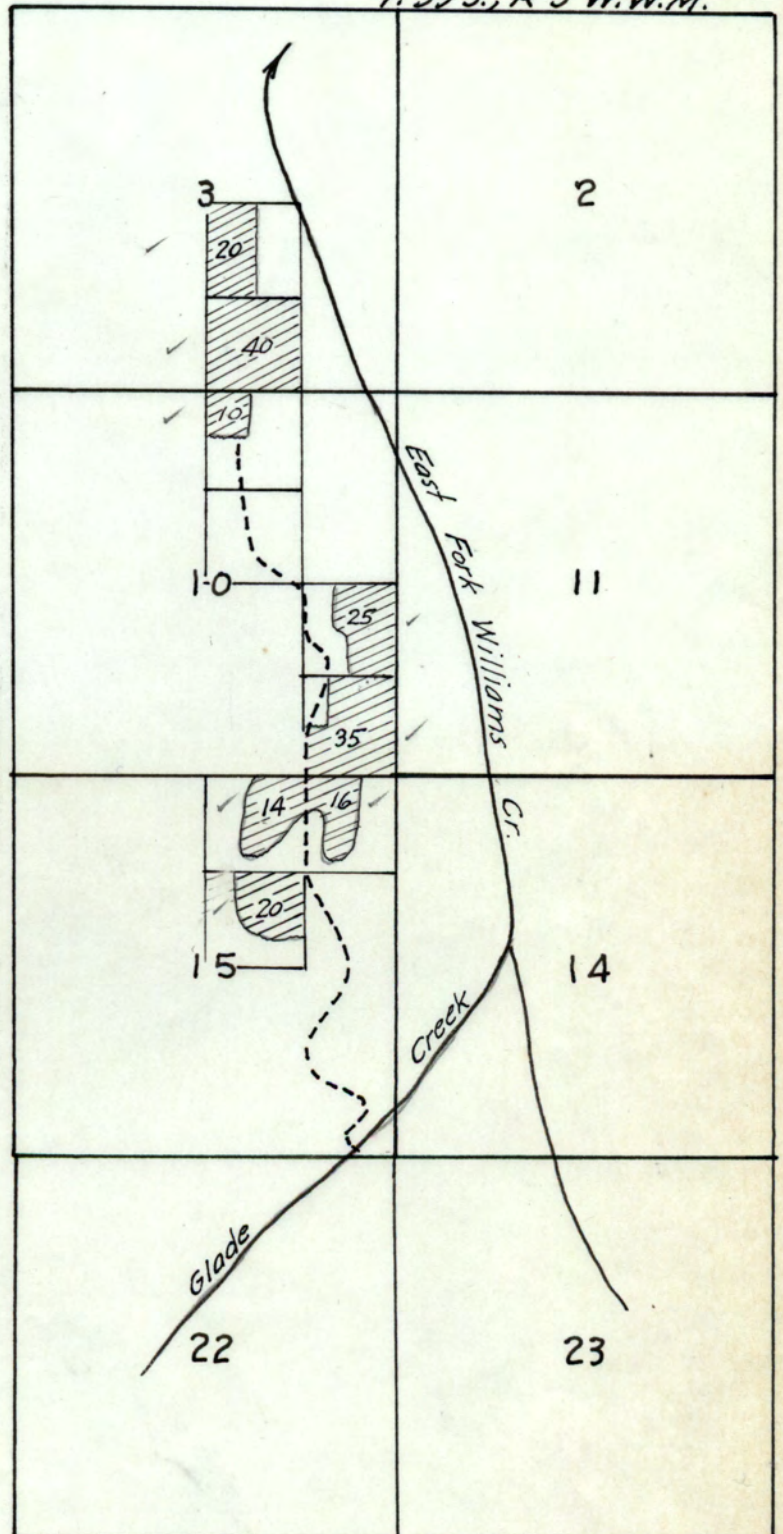

Dear Mr. Rogers:

I have checked out the water rights in regard to the Jack Miller (Virgil Berry #2693) cancelation. I saw Mr. Sorrels who has lived in the area since the original adjudication. He stated that the water has been used on all the property in Section 10 - Della Morrison NE $\frac{1}{4}$ SE $\frac{1}{4}$  25 acres, SE $\frac{1}{4}$ SE $\frac{1}{4}$  35 acres, Twp 39 S, Range 5 WWM.

On the same permit #2693 Emil Voss has been using water on 14 acres in NW $\frac{1}{4}$ NE $\frac{1}{4}$ , 16 acres in NE $\frac{1}{4}$ NE $\frac{1}{4}$  and 20 acres in SW $\frac{1}{4}$ NE $\frac{1}{4}$ , section 15, Twp 39 S, R 5 WWM. I recommend that these rights be re-issued.

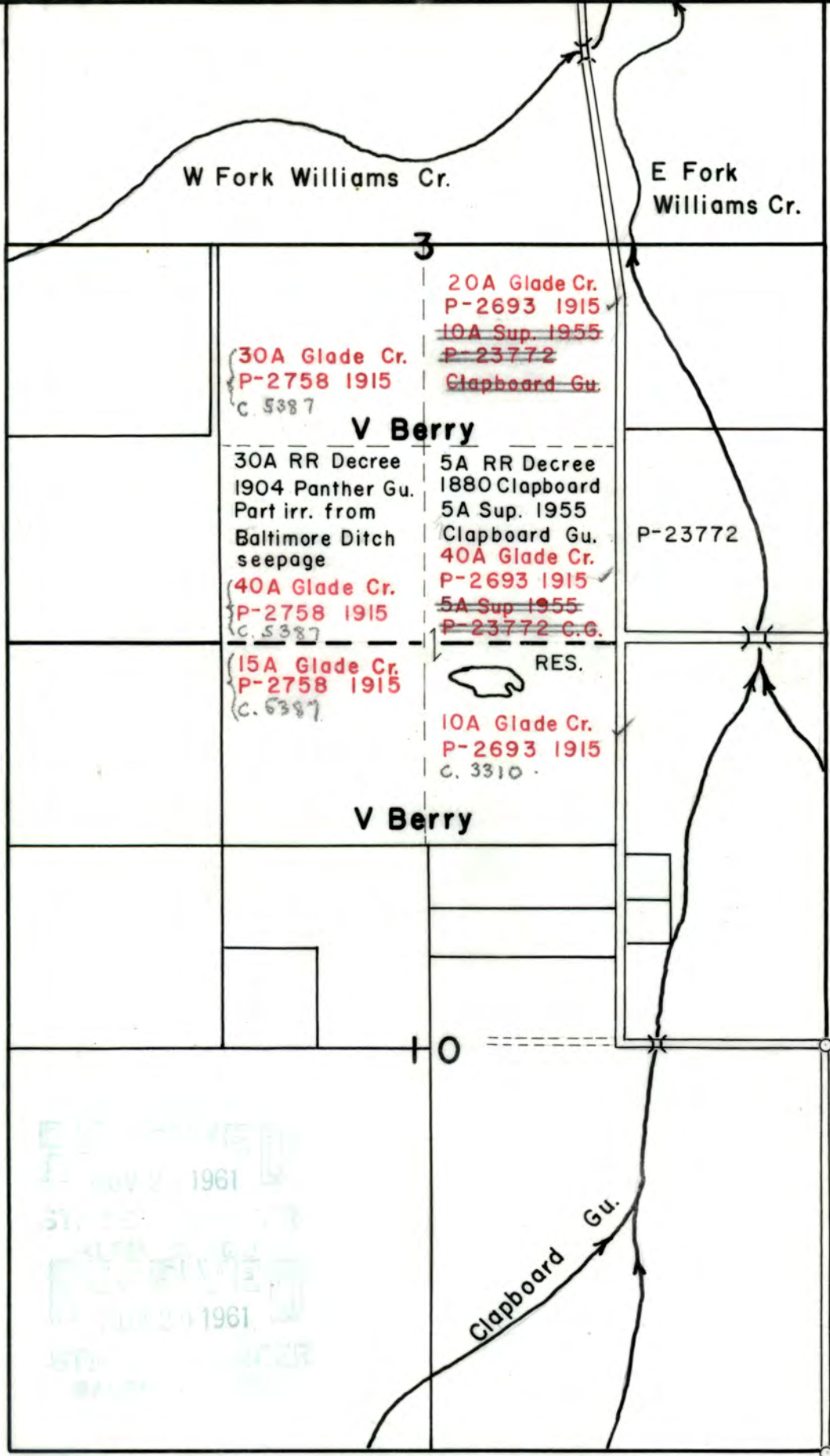
There is another right that has come to my notice that at one time probably used water through this same ditch. There is no other ditch in the area that is possible to use. The water as you know hasn't gone past the flume that was located in NE $\frac{1}{4}$ SE $\frac{1}{4}$  of Sec. 10 Twp 39 S R 5 WWM. The right that I question is 15 acres in SE $\frac{1}{4}$ SE $\frac{1}{4}$  of Section 3 Twp 39 S R 5 WWM, permit #2822 issued Feb. 23, 1916 in the name of Ethel Griffith. The permit calls for water from Glade Fork. There has been some confusion as to the proper name of the creek on the maps. I feel that this right was intended to be taken from the creek we now identify as Rock Creek. This property is occupied by Mr. Balou, Williams, Oregon. The owner according to the assessor's office is in the name of Henry & Corinne Alisch, P.O. Box 1208, Dhapsan, Saudi, Arabia.

You are hereby notified that the State Engineer is initiating proceedings under the provisions of ORS 540.631 to 540.650 for the cancelation on grounds of abandonment of a part of a certain water right as hereinafter described.

The water right in question is a part of the right established under Permit No. 2693 and confirmed by certificate of water right issued to S. A. McCune, Ada R. Hicks, H. N. Hammond, W. S. Hammond and H. B. Hammond and recorded at page 3310, Volume 4, State Record of Water Right Certificates. Said right in question is for the use of the waters of Glade Creek, a branch of Williams Creek, for the irrigation of 40 acres in the SW $\frac{1}{4}$  SE $\frac{1}{4}$  and 20 acres in the NW $\frac{1}{4}$  SE $\frac{1}{4}$ , Section 3, and 10 acres in the NW $\frac{1}{4}$  NE $\frac{1}{4}$ , Section 10, Township 39 South, Range 5 West, W. M., with a date of priority of September 27, 1915.

Written notice of said hearing will be given at least 10 days prior to the date set.

Dear Sir:-

In regard to the above applications there are various times set for the complete application of water for beneficial use. The waters from the East fork of Williams Creek and Glade fork which is a tributary of the East fork, have been appropriated, during the dry months by the Layton Mining Company, but owing to a desision by the Water board the farmers were to have this water during certain months of the summers, and it was owing to this adjudication that we made application.

The Layton Co. appealed from that desision, holding the water untill the matter was was again decided, and owing to the uncertainty we have none of us made complete application of the water, and have thus been held up for a matter of two years. The final adjudication has quite recently been made in accordance with the first desision, so now we can go ahead with the clearing of land if we can get an extention of time to make the application of water to the lands in question.

We would therefore most respectfully ask that in the case of Application No. 4614, permit No. 2741, W.S.Hammond, he be given two years extention, in the case of application No.4538, permit No. 2693, S.A.McCune be given Three years, Ada R.Hicks be given Three years, and H.N.Hammond et, al. be given two years.
