The maximum height will be 19.0 feet above the stream bed or ground surface at the centerline. The top width will be 10.0 feet , slope of upstream face 3:1 , slope of downstream face2:1 , and height of dam above water line when full 5.0 feet

The area submerged by the reservoir, when full, will be 5.7 acres , and the maximum depth of water will be 12.8 feet
