This is to certify, That JOHN W. WILSON

of HC 74, Box 12101, Hines , State of OR 97738 , has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of a well a tributary of Sage Hen Creek (Malheur Lake) for the purpose of irrigation of 104.7 acres and that said right to the use of said waters has been perfected in under Permit No. G-6468 accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 31, 1975 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.31 cubic feet per second or its equivalent in case of rotation, measured at the point of diversion from the well. The well is SW 1/4 SE 1/4, Section 18, T24S, R30E, WM; 860 feet South and 820 feet East from NW corner SW 1/4 SE 1/4, Section 18.
