Dear Mr. and Mrs. Kreder:

THIS IS NOT A PERMIT AND IS SUBJECT TO CHANGE AT THE NEXT PHASE OF PROCESSING.

This letter is to inform you of the preliminary analysis of your water use permit application and to describe your options. In determining whether a water use permit application may be approved, the Department must consider the factors listed below, all of which must be favorable to the proposed use if it is to be allowed. Based on the information you have supplied, the Water Resources Department has made the following preliminary determinations:

Initial Review Determinations:

- 1. The application proposed the use of 600.0 gallons per minute, or 1.34 cubic feet per second (CFS), from Well 1 in West Fork Palmer Creek Basin for irrigation use on 95.9 acres and supplemental irrigation use on 124.5 acres from March 1 through October 31.
- 2. The proposed use is not prohibited by law or rule except where otherwise noted below.
- 3. The use of water from Well 1 in West Fork Palmer Creek Basin for irrigation use and supplemental irrigation use is allowable under the Willamette Basin Program.
- 4. Ground water will not likely be available in the amounts requested without injury to prior rights and/or within the capacity of the resource.
 - The Department has determined, based upon OAR 690-009, that the proposed ground water use will have the potential for substantial interference with an unnamed tributary of West Fork Palmer Creek and West Fork Palmer Creek. Therefore, in accordance with OAR 690-400-0010(11)(a)(B), surface water availability must also be considered. Surface water is not available in the amount requested during the period July 1 through September 30.
- 6. Your application requested a completion date of 2014. The Department requires completion of construction and complete application of the water to the use within 5

years from issuance of the permit under ORS 537.230. Any permit, if issued, will allow no more than 5 years to complete construction and make beneficial use of the water.

Summary of Allowable Water Use

Because not all items above are favorable, the use of 1.34 CFS of water from Well 1 in West Fork Palmer Creek Basin for irrigation use on 95.9 acres and supplemental irrigation use on 124.5 acres is not allowable, and it appears unlikely that you will be issued a permit. At this time, you must decide whether to proceed or to withdraw your application as described below.

Please reference the application number when sending any correspondence regarding the conclusions of this initial review. Comments received within the comment period will be evaluated at the next phase of the process.

Withdrawal Refunds:

If you choose not to proceed, you may withdraw your application and receive a refund (minus a \$150 processing charge per application.) To accomplish this you must notify the Department in writing by **Friday, October 3, 2008**. For your convenience you may use the enclosed "STOP PROCESSING" form.

To Proceed With Your Application:

If you choose to proceed with your application, you do not have to notify the Department. Your application will automatically be placed on the Department's Public Notice to allow others the opportunity to comment. After the comment period the Department will complete a public interest review and issue a Proposed Final Order.

If A Permit Is Issued It Will Likely Include The Following Conditions:

- 1.Measurement, recording and reporting conditions:
 - A. Before water use may begin under this permit, the permittee shall install a totalizing flow meter or other suitable measuring device as approved by the Director at each point of appropriation. The permittee shall maintain the meter or measuring device in good working order, shall keep a complete record of the amount of water used each month, and shall submit a report which includes the recorded water use measurements to the Department annually or more frequently as may be required by the Director. Further, the Director may require the permittee to report general water-use information, including the place and nature of use of water under the permit.

B. The permittee shall allow the watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.

This initial review does not attempt to address various public interest issues such as sensitive, threatened, or endangered fish species. These issues will be addressed as the Department reviews comments from the public and other agencies, and prepares a proposed final order. You should be aware that, if significant public interest issues are found to exist, such a finding could have an impact on the eventual outcome of your application.

The water source identified in your application may be affected by an Agricultural Water Quality Management Area Plan. These plans are developed by the Oregon Department of Agriculture (ODA) with the cooperation of local landowners and other interested stakeholders, and help to ensure that current and new appropriations of water are done in a way that does not adversely harm the environment.
