**FINAL ORDER
APPROVING THE USE OF
STORED WATER**

Authority

ORS 537.147 establishes the process by which an application to use stored water exclusively may be submitted. OAR Chapter 690, Divisions 310 and 340 implement the statute, and provide the Department's procedures and criteria for evaluating applications to use stored water exclusively.

Findings of Fact

1. On March 18, 2008, Ryan Maxson submitted an application for a water-use permit pursuant to ORS 537.147. The Department provided public notice of the application in the Department's weekly public notice on April 1, 2008. A 30-day comment period followed.
2. The Department has evaluated the application and any comments received, and finds that no public interest in ORS 537.170(8) would be affected adversely by the proposed use.
3. Your application proposed to appropriate 45.0 acre-feet (AF) of water from Maxson Ponds – South Pond (Permit R-14609) and Maxson Ponds – North Pond (Permit R-14610). However, Maxson Ponds – South Pond and Maxson Ponds – North Pond are only permitted to store a total of 35.0 AF of water. Therefore, the volume allowed will be limited to 35.0 AF of water.


Conclusions of Law

Application S-87129 is consistent with the requirements of ORS 537.147, and OAR Chapter 690.

Now Therefore, it is Ordered:

Application S-87129 is approved, and Permit Number S-54467 is issued as limited by the conditions contained therein.
