Lewis, being first duly sworn, depose and say, that I have E correctly surveyed the tract of land represented by and included in Lots one (1) to eighteen (18) inclusive, "Osburn Avenue", and that part of "County Road number 587" which is included within the boundaries of said Lots seven (7) to eleven inclusive, the dimensions of each and every one of said Lots being given to. the center line of "Osburn Avenue" and of "County Road number 587", which are the whole of the component and essential parts of the accompanying plat or map of "Osburn Park Tract"; and there are appropriate monuments established at the corners of said lots. The portions of the Oregon Railway and Navigation Company and the Oregon Water Power Company right of ways, and the properties of Joshua Ledbury and A. L. Turner, are not a part of said plat, but are depicted upon said accompanying map for the purpose of showing their respective relations to the property platted and facilitating the tracing of the chain of title thereto. At "A" "the initial point of the survey" there is planted a stone boulder about 18" x 6", vertically on end, about 22" in debth, tamped firmly into palce, with a + cut into its top at the exact point at 980.76' distance from the southeast corner of in the south boundary line of the Jacob Zimmerman Donation Land Claim, in Township number one (1) North of the Base Line and Range number three (3) East of the Willamette Meridian, in the County of Multnomah, State of Oregon. At "B", the southwest corner of "Lot 7", there is planted a fragment of stone slab about 16" x 10" E. & W. x 3" N. & S., vertically on end, about 15" in debth, tamped Rim firmly into place, with a + cut into its top at the exact point. At "C" the southeast corner of "Lot 7", there is planted a rough fragmentary stone slab, about 14" x 9" E. & W. x 3" N. & S., vertically on end, tamped firmly into place, about 12" in debth, with a + cut into its top at the exact point. At "D", the northeast corner of the east part of "Lot 7", there is planted a stone boulder 12" x 9" E. & W. x 4" N. & S., vertically on end, tamped firmly into place, about 12" in debth, with a + cut into its top at the exact point. At "E", the reent trant corner of "Lot 7", there is planted a rough stone about 17" x 11" x 6", xx vertically on end, about 24" in debth, tamped firmly into place, with a + cut into its top at the exact point. At "F" the point of intersection of the east home boundary line of "Lot 7" with the south boundary line of "Country Road Number 587", there is planted a rough stone about 14" x 9" x 6", vertically on end, about 21" in debth, tamped firmly into place, with a + cut into its top at the E exact point. At "G" the angle in the south boundary line of opposite to "R < 24" of "county Road Number 587", there is planted a rough crumbly stone, about 16" x 9" x 6", vertically on end, about 22" in debth, tamped firmly into place, with a + cut into its top at the exact point. At "H" the "R < 24" of "Country Ro ad Number 587" There is planted a rough irregular shaped fragment of a stone boulder about 20" x 15" x 12", about vertically on end, about 23" in debth, tamped firmly into palce, with a + cut into its top at the exact point. At "I" there is plant ed a piece of Bessimer Steel car axle, about 11" in length x 2 3/4" in diameter, with a circular head on its upper end, about 4 1/2" in diameter x 1 1/8" thick, vertically on end, about 11" in debth in the earth, with a + cut into its top at the exact point. At "J" there is driven a black iron pipe that has been painted

green, about 24" in length x 1 1/4" in diameter, vertically on end, about 21" in debth. "I" and "J" marking the east boundary line of the Joshua Ledbury land, south of the south boundary line of "County Road Number 587".
