**THIS IS NOT A PERMIT AND IS
SUBJECT TO CHANGE AT THE NEXT PHASE OF PROCESSING.**

This letter is to inform you of the preliminary analysis of your water use permit application and to describe your options. In determining whether a water use permit application may be approved, the Department must consider the factors listed below, all of which must be favorable to the proposed use if it is to be allowed. Based on the information you have supplied, the Water Resources Department has made the following preliminary determinations:

Initial Review Determinations:

1. The application proposed the use of 50.0 cubic feet per second (CFS) of water from Columbia River, a tributary of Pacific Ocean, for irrigation use on 1351.0 acres and supplemental irrigation use on 5065.7 acres year-round.
2. The proposed use is not prohibited by law or rule except where otherwise noted below.
3. The use of water from Columbia River, a tributary of Pacific Ocean, for irrigation use and supplemental irrigation use is allowable under the Umatilla Basin Program.
4. Surface water is available in the amount and for the full period requested.
5. OAR 690-033-0120(2) prohibits the diversion of water from April 15 through September 30 of each year.
6. The updated map submitted with your application shows that you are applying for 1222.9 acres of irrigation use and 4805.2 acres of supplemental irrigation use, whereas your application shows that you are applying for 1351.0 acres of irrigation use and 5065.7 acres of supplemental irrigation use. Please submit information to clarify the intended acreage. If the map is incorrect, you will need to submit an updated map. If you do not

submit clarification by July 17, 2008, on this matter, we will rely on acreage shown on your map.

7. Per OAR 690-350, a separate application for use of water for aquifer storage and recovery projects shall be submitted to the Department. Water use for aquifer storage and recovery projects will not be considered a part of the review for application S-87076.

8. **Newspaper Publication Requested**

You indicated on the application form that you do not own all the land where you propose to divert, transport, and use water. OAR 690-310-0020(1) requires that the Department provide notice to all affected landowners prior to issuing a permit. OAR 690-310-0020(2) specifies that if there are more than 25 landowners involved in the proposed use, the notice may be satisfied by publishing a notice of the application for three consecutive weeks in a publication which meets the statutory definition of "newspaper" under ORS 193 for the purpose of public notice. The cost of the publication is to be paid by the applicant.

The Department requests that you have the required notice published. The language to be used in the notice is attached. A copy of the affidavit of publication must be submitted to the Department following completion of the notice period. If the three weekly notices have not been published within 45 days from the date of this Initial Review, please submit a receipt demonstrating that this process has been initiated.

Summary of Initial Determinations

Because not all items above are favorable, the use of 50.0 CFS of water from Columbia River, a tributary of Pacific Ocean, for irrigation use on 1351.0 acres and supplemental irrigation use on 5065.7 acres year-round is not allowable, and it appears unlikely that you will be issued a permit. At this time, you must decide whether to proceed or to withdraw your application as described below.

Please reference the application number when sending any correspondence regarding the conclusions of this initial review. Comments received within the comment period will be evaluated at the next phase of the process.

Withdrawal Refunds:

If you choose not to proceed, you may withdraw your application and receive a refund (minus a \$150 processing charge per application.) To accomplish this you must notify the Department in writing by **Friday, July 11, 2008**. For your convenience you may use the enclosed "STOP PROCESSING" form.

To Proceed With Your Application:

If you choose to proceed with your application, you do not have to notify the Department. Your application will automatically be placed on the Department's Public Notice to allow others the opportunity to comment. After the comment period the Department will complete a public interest review and issue a proposed final order.

If A Permit Is Issued It Will Likely Include The Following Conditions:

1. Measurement, recording and reporting conditions:
 - A. Before water use may begin under this permit, the permittee shall install a totalizing flow meter or other suitable measuring device as approved by the Director at each point of diversion. The permittee shall maintain the meter or measuring device in good working order, shall keep a complete record of the amount of water used each month, and shall submit a report which includes the recorded water use measurements to the Department annually or more frequently as may be required by the Director. Further, the Director may require the permittee to report general water-use information, including the place and nature of use of water under the permit.
 - B. The permittee shall allow the watermaster access to the meter or measuring device; provided however, where the meter or measuring device is located within a private structure, the watermaster shall request access upon reasonable notice.
2. You may be required to install fish screens at the point of diversion to meet Oregon Department of Fish and Wildlife specifications for adequate protection of aquatic life.
3. The use allowed herein may be made when water can be put to beneficial use by irrigation, either for immediate crop growth or for forecast requirements to raise the soil moisture to field capacity to be utilized by plant growth in the subsequent growing season.
4. The use of water for out-of-season irrigation allowed herein shall not establish priority of right against future appropriations for beneficial uses or storage for such beneficial uses, other than rights for irrigation during the allowed period of use.
5. Should this permit be used as the base right for an aquifer storage and recovery project, the limited period of use stipulated herein shall not apply to water withdrawn from storage.
6. The season of use for all acreage for supplemental irrigation use under this application shall be limited to the underlying primary right, being the irrigation season.

This initial review does not attempt to address various public interest issues such as sensitive, threatened, or endangered fish species. These issues will be addressed as the Department reviews comments from the public and other agencies, and prepares a proposed final order. You should be aware that, if significant public interest issues are found to exist, such a finding could have an impact on the eventual outcome of your application.

The water source identified in your application may be affected by an Agricultural Water Quality Management Area Plan. These plans are developed by the Oregon Department of Agriculture (ODA) with the cooperation of local landowners and other interested stakeholders, and help to ensure that current and new appropriations of water are done in a way that does not adversely harm the environment.
