PUBLIC INTEREST PRESUMPTION; GROUNDWATER

OAR 690-310-130 (1) *The Department shall presume that a proposed groundwater use will ensure the preservation of the public welfare, safety and health as described in ORS 537.525.* Department staff review ground water applications under OAR 690-310-140 to determine whether the presumption is established. OAR 690-310-140 allows the proposed use be modified or conditioned to meet the presumption criteria. **This review is based upon available information and agency policies in place at the time of evaluation.**

B3. **Ground water availability remarks:** Alluvial wells in the vicinity appear to be relatively stable. I suggested to the applicant's agent that an application for an alluvial well may be possible following my review of the previous application for a basalt well.

Basis for aquifer hydraulic connection evaluation: The alluvial aquifer pinches out against basalt rocks near the Service Anticline and does not extend to the Umatilla River. Interference with the N Canal to the south is likely, but this should not be evaluated as a surface water source under Division 9 rules.
