INTRODUCTION

Claimant JELD-WEN, inc. (Running Y Ranch) ("Claimant") and Contestant the United States of America (the "United States") ("Contestant") (the Claimant and Contestant together as the "Parties"), and the Oregon Water Resources Department ("OWRD"), agree and stipulate as follows:

A. STIPULATED FACTS

1. On January 15, 1991, Claimant's predecessor-in-interest filed Claim 144 with OWRD. The claimed place of use for Claim 144 is certain real property located in portions of Sections 29, 31, 32, and 33, Township 37 South, Range 8 East of the Willamette Meridian ("W.M."), and Sections 4, 5, 6, 7, 8, 9, 16, 17, 18, 20, 21, 22, 27, 28, 29, and 34, Township 38 South, Range 8 East, W.M.

Page 1 – STIPULATION TO RESOLVE CONTESTS 2044 AND 3828 TO KBA CONSOLIDATED CASE 118, CLAIM 144

Horsefly and Langell Valley Irrigation Districts voluntarily withdrew from Contest 3138 on May 28, 2002. Medford and Rogue River Valley Irrigation Districts' Contest 3138 was resolved by stipulation. See STIPULATION TO RESOLVE CONTEST 3138 AGAINST CLAIM 144 dated March 23, 2006.

The Klamath Tribes voluntarily withdrew, without prejudice, Contest 4169. See KLAMATH TRIBES' WITHDRAWAL OF CONTESTS dated August 14, 2006.

- 2. On October 4, 1999, OWRD issued its Preliminary Evaluation of Claim 144, preliminarily approving the claim.
- 3. The following contests were filed to Claim 144: Contest 2044, filed by Claimant's predecessor-in-interest; Contest 3138, filed by Horsefly, Langell Valley, Rogue River Valley, and Medford Irrigation Districts; Contest 3828, filed by the United States of America; and Contest 4169, filed by the Klamath Tribes. Langell Valley and Horsefly Irrigation Districts voluntarily withdrew from Contest 3138 on May 28, 2002. Medford and Rogue River Valley Irrigation Districts' Contest 3138 was resolved by stipulation. *See* Stipulation to Resolve Contest 3138 Against Claim 144 dated March 23, 2006. The Klamath Tribes voluntarily withdrew, without prejudice, Contest 4169 on August 14, 2006. Contests 2044 and 3828 are collectively referred to hereinafter as the "Contests."
- 4. The Parties and OWRD agree the Contests can be resolved without the need for further proceedings, pursuant to the terms below.

B. TERMS AND CONDITIONS

- 1. The Parties and the OWRD agree that Claim 144 should be approved by the Adjudicator as described below:
 - a. **SOURCE**: Upper Klamath Lake, tributary to Klamath River.
 - b. **LOCATION OF POINTS OF DIVERSION**:

Point of Diversion ("POD") #1: Government Lot 3, NENW, Section 32, Township 37 South, Range 8 East, W.M.

POD #2: SESE, Section 29, Township 37 South, Range 8 East, W.M.

POD #3: Government Lot 5, SENW, Section 7, Township 38 South, Range 8
East, W.M. The approximate location of the PODs is shown on the map included in OWRD Exhibit 1 at page 155, a true and correct copy of which map is attached hereto at **Exhibit A** (the "Claim Map").

- c. USE: Irrigation of 5569.5 acres (1194.4 acres POD #1, 424.0 acres POD #2, 3951.1 acres POD #3) and livestock watering of 4500 head (PODs #1, #2, and #3). To facilitate livestock watering, water may be diverted as reasonably necessary to transport the water and to prevent the ditches and channels from being completely frozen, but at no time shall more water be diverted than has been historically diverted for beneficial use and is reasonably necessary to transport the water and to prevent the ditches and channels from being completely frozen.
- d. **DIVERSION RATE**: 69.32 cubic feet per second ("cfs") for irrigation, with 14.93 cfs for irrigation from POD #1, 5 cfs for irrigation from POD #2, and 49.39 cfs for irrigation from POD #3; and 54,000 gallons per day ("gpd") from PODs #1, #2, and #3 (combined) for livestock watering
- e. **DUTY**: 3.0 acre-feet/acre
- f. **PERIOD OF USE**: January 1 through December 31 for irrigation and for livestock watering
- g. **PRIORITY DATE**: December 31, 1889
- h. **PLACE OF USE**:

Use of water under Claim 144 on the following place of use, when combined with use of water under any other right adjudicated in the Klamath Basin Adjudication for any portion or all of the same place of use, may not exceed the rate and duty necessary for beneficial use as determined in the Klamath Basin Adjudication.

The Parties and OWRD agree that under the terms and provisions of this Stipulation, the Contests have been satisfactorily resolved, and when viewed in light of the Stipulation to Resolve Contest 3138 Against Claim 144, such resolution of the Contests ends the need for further proceedings before the Administrative Law Judge on the Contests.
- 3. Based on the Stipulation of the Parties that Claim 144 and the Contests can be resolved without the need for further proceedings, OWRD adjudication staff hereby recommends to the Adjudicator that Claim 144 be withdrawn from the Office of Administrative Hearings. OWRD adjudication staff further recommends that Claim 144 be approved in the Findings of Fact and Order of Determination issued by the Adjudicator in accordance with the terms of paragraph B.1 above, and further in accordance with the Stipulation to Resolve Contest 3138 Against Claim 144.
- 4. If the Findings of Fact and Order of Determination issued by the Adjudicator for Claim 144 does not conform with the terms set forth in paragraph B.1, above, the Parties reserve any rights they may have to file exceptions to the Findings of Fact and Order of Determination as to Claim 144 with the Adjudicator or in the courts, and otherwise reserve any rights they may have to participate in any further proceedings authorized by law concerning Claim 144.
- 5. The Parties and OWRD agree that this Stipulation has been reached through good faith negotiations for the purpose of resolving legal disputes, including pending administrative action. The Parties and OWRD agree that no offers and/or compromises made in the course of negotiations shall be construed as admissions against interest. The Parties and OWRD agree that

This Stipulation shall be binding upon and shall inure to the benefit of the Parties and OWRD and their respective heirs, executors, administrators, trustees, beneficiaries, predecessors, successors, affiliated and related entities, officers, directors, principals, agents, employees, assigns, representatives, and all persons, firms, associations, and/or corporations connected with them.
