The Oregon Water Resources Department and Jessie L. Puckett, Claimant and Contestant, do hereby agree and stipulate as follows:

Stipulated Facts

- 1. On October 15, 1990, Jessie L. Puckett ("Claimant") submitted a statement and proof of claim (Claim 189) to the Oregon Water Resources Department ("Department") for 50 gallons per minute from the Klamath River for irrigation of approximately 0.5 acres as part of the Klamath adjudication. Claimant claimed an 1873 priority date for this use.
- On October 4, 1999, the Adjudicator preliminarily denied Claim 189 as part of the Department's preliminary evaluation. The Adjudicator found that the record did not contain substantial evidence of use of water or construction of works prior to February 24, 1909, nor evidence of completion of works within a reasonable time after commencement of construction or use of water.
- 3. On April 19, 2000, the Claimant submitted to the Department a contest (Contest 19) to the preliminary evaluation of Claim 189, contesting denial of the claim, providing additional information about the use of water on the property and demanding a hearing. On May 8, 2000, Horsefly Irrigation District also *et al.* filed a contest (Contest 3179) to Claim 189, but subsequently withdrew that contest on December 20, 2001.

4. Department staff reviewed the information submitted in Contest 19 and conclude that Claim 189, as supplemented by the information submitted in Contest 19, can be approved according to the following terms.

Use: Irrigation of 0.7 acres

Amount of Water Beneficially Used: 0.02 cubic feet per second, measured at the point of diversion.

Period of Use: March 1 - October 31

Priority Date: December 31, 1873

Place of Use: Lots 1 and 3 SW 1/4 SW 1/4 and SE 1/4 SW 1/4

Township 39 South, Range 8 East, W.M.
