The Oregon Water Resources Department (OWRD), Claimants Steven Lawrence and James Lawrence (Claimants), United States and Klamath Tribes (Contestants) hereby agree and stipulate as follows:

1- STIPULATION TO RESOLVE CONTEST CADOCUMENTS AND SETTINGSVAMES LAWRENCE/LOCAL SETTINGS/TEMPORARY INTERNET FILES/CONTENT.IES/IOILIFC

A. STIPULATED FACTS

- 1. On January 30, 1991, Claimants filed Claim No. 13 in the Klamath Adjudication.
- 2. On October 4, 1999, the Adjudicator issued his preliminary evaluation of Claim 13, preliminarily approving the claim, but for less acreage and a smaller quantity of water than was claimed. On May 8, 2000, the Klamath Tribes and the United States of America filed Contests 4075 and 3719, respectively, to both Claim 13 and the Adjudicator's Preliminary Evaluation of Claim 13 for the following reasons:
 - a. That there is insufficient title information to establish a <u>Walton</u> right for a portion of the Place of Use;
 - b. That there is insufficient information on the development or continuous use of water on this Place of Use to establish a Walton right;
 - c. The period of use in the preliminary evaluation exceeds the period of use claimed.
- 3. On May 4, 2000, Steven Lawrence, James B. Lawrence and John H. Lawrence filed Contest 1787 against the Adjudicator's Preliminary Evaluation of Claim 13.
- 4. On May 8, 2000, Klamath Irrigation District; Klamath Drainage District; Tulelake Irrigation District; Klamath Basin Improvement District; Ady District Improvement Company; Enterprise Irrigation District; Klamath Hills District Improvement Company; Malin Irrigation District; Midland District Improvement Company; Pine Grove Irrigation District; Pioneer District Improvement Company; Poe Valley Improvement District; Shasta View Irrigation District; Sunnyside Irrigation District; Don Johnston & Son; Bradley S. Luscombe; Berlva Pritchard, Don Vincent, Randy Walthall; Inter-County Title Co.; Winema Hunting Lodge, Inc.; Van Brimmer Ditch

Company; Plevna District Improvement Company; and Collins Products, LLC, filed Contest 3435 to Claim 13 and indicated in said contest that they accepted the Adjudicator's Preliminary Evaluation of Claim 13. Those contestants withdrew their Contest 3435 on December 4, 2000.

- 5. Ross Waples, Soil Scientist, and L. Ralph Saunders, Aerial Photography Interpreter, both employed by HKM Engineering, Inc, are witnesses for Contestant United States who, if called to testify, will state that aerial photographs from 1952 and 1994 evidence that 112.8 acres north of Road 3149 within the claimed area were under irrigation as of those dates and that all available evidence supports Claimants' Walton Claim for that portion of their claim.
- 6. OWRD, Claimant and Contestants agree that Contests 1787, 3435 and 4075 can be resolved without the need for a hearing pursuant to the terms outlined below.

B. TERMS OF THE AGREEMENT

- 1. OWRD, Claimant, and Contestants agree that Claim 13 should be approved by the Adjudicator for 112.8 acres of the claimed acreage north of Road 3149 within the Place of Use as described below:
 - a. POINT OF DIVERSION LOCATION: SW1/4 SE1/4, Section 1, Township 31 South, Range 10 East, W.M.
 - b. SOURCE: Williamson River, tributary to Upper Klamath Lake
 - c. USE: Irrigation of 112.8 acres and livestock use
 - d. AMOUNT ACTUALLY BENEFICIALLY USED: 2.82 cubic feet per second for irrigation, and 8,122 gallons per day for livestock, measured at the point of diversion.
 - e. PERIOD OF USE: March 1 October 31 for irrigation; January 1 December 31 for livestock.
 - f. PRIORITY DATE: October 14, 1864

- 4. If the Final Order of Determination issued by the Adjudicator for Claim 13 does not follow the terms listed in paragraph B.1 above, Claimant and Contestants reserve any rights they may have to file exceptions to the Final Order of Determination as to Claim 13 in the Circuit Court for Klamath County, and reserve any rights they may have to participate in any future proceedings authorized by law.




AREA ARE IN ACRES
