The Oregon Water Resources Department (OWRD), Claimant Silverbow Ranch, LLC (Claimant), and Contestants Klamath Project Water Users (KPWU) (Contestants) hereby agree and stipulate as follows:

A. STIPULATED FACTS

1. On December 7, 1990, Kendall A. Tait filed Claim 90 in the Klamath Adjudication. Silverbow Ranch, LLC (Claimant), subsequently purchased the property that is the subject of Claim 90.

- 2. On October 30, 1990, Raleigh and Diane L. Wirth, Trustees of the Wirth Family Trust, filed Claim 93 in The Klamath Adjudication. Silverbow Ranch, LLC (Claimant), subsequently purchased the property that is the subject of Claim 93.
- 3. On October 4, 1999, the Adjudicator issued his Preliminary Evaluations of Claims 90 and 93, preliminarily approving both claims, but for a smaller quantity of water than was claimed.
- 4. On May 8, 2000, the KPWU filed Contests 3474 and 3476 to Claims 90 and 93, respectively, and indicated in said contests that the KPWU accepted the Adjudicator's Preliminary Evaluations of Claims 90 and 93. No other contests were filed to Claims 90 and 93, or the Preliminary Evaluations for these claims.
- **5.** OWRD, Claimant, and Contestants agree that Contests 3474 and 3476 can be resolved without the need for a hearing pursuant to the terms outlined below.

B. TERMS OF THE AGREEMENT

- 1. OWRD, Claimant, and Contestants agree that Claims 90 and 93 should be approved by the Adjudicator according to the terms of the Adjudicator's October 4, 1999 Preliminary Evaluations for these claims, as follows:
 - (a) Claim 90:
 - 1. POINT OF DIVERSION LOCATION: Government Lot 14, Section 21, Township 35 South, Range 7 East, W.M.
 - 2. SOURCE: Williamson River, tributary to Upper Klamath Lake
 - 3. USE: irrigation of 15.4 acres
 - 4. AMOUNT ACTUALLY BENEFICIALLY USED: 0.39 cubic feet per second, measured at the point of diversion.
 - 5. PERIOD OF USE: March 1 October 31

- 7. PLACE OF USE:

 - 4. AMOUNT ACTUALLY BENEFICIALLY USED: 0.34 cubic feet per second, measured at the point of diversion.
 - 5. PERIOD OF USE: March 1 October 31
 - 6. PRIORITY DATE: October 14, 1864
 - 7. PLACE OF USE:

NE ¼ NW ¼ 4.0 ACRES IRRIGATION
SE ¼ NW ¼ 9.6 ACRES IRRIGATION

2. OWRD, Claimant, and Contestants agree that pursuant to the terms of this Agreement, Contests 3474 and 3476 have been satisfactorily resolved, and such resolution vitiates the need for a hearing before the Hearing Officer on these contests to Claims 90 and 93.

- 3. Based upon the agreement of OWRD, Claimant, and Contestants that Claims 90 and 93, and the contests thereto, can be resolved without the need for a hearing, OWRD adjudication staff hereby recommends to the Adjudicator that Claims 90 and 93 be approved in the Final Order of Determination issued by the Adjudicator in accordance with the terms of paragraph B.1, above.
- 4. If the Final Order of Determination issued by the Adjudicator for Claims 90 and 93 do not follow the terms listed in paragraph B.1., above, Claimant and Contestants reserve any rights they may have to file exceptions to the Final Order of Determination as to Claims 90 and 93 in the Circuit Court for Klamath County, and reserve any rights they may have to participate in any future proceedings authorized by law.
