THIS MATTER having come before the Court on the Petition of Anthony P. Pagliarulo, as supported by the sworn Watermaster Affidavit / Consent to Petition to Amend Grande Ronde River Decree of Shad Hattan, the appointed Watermaster for District 6, acting on behalf of the State of Oregon under the authority of the Director For the Oregon Water Resources Department filed herewith, and it appearing thereby that that portion of the Grande Ronde River Decree which confirms the appurtenant water rights for the real property of Petitioner as confirmed by a Decree of the Circuit Court for the State of Oregon for Union County in the name of H.P. Stewart and entered of record at Salem in the Order Record of the State Engineer, in Volume 8 at Page 1, contains a scrivener's error by omission of the source for the water right awarded in the name of H.P. Stewart and should be corrected accordingly; and it further appearing to the Court that there is no necessity to serve other water users on the Little Creek system as such Amendment will not alter the distribution of water nor in any way adversely

2 the Court be fully advised, It is therefore HEREBY ORDERED, ADJUDGED AND DECREED as
3 follows:

5 The Grande Ronde River Decree, a Decree of the Circuit Court of the State of Oregon
6 for Union County and entered of record at Salem in the records of Water Resources Department
7 in Volume 8, Page 1, which includes a water right issued in the name of H.P. Stewart, and
8 which right includes the irrigation of 17.5 acres on portions of Tax Lot 4200 of Union County
9 Assessor's Map 04S40 owned by Anthony P. Pagliarulo in the following described quarter
10 sections:

11 In Township 4 South, Range 40 East., W.M.:

12 Section 20: Northeast quarter Southeast quarter

13 Section 21: Northwest quarter Southwest quarter

14 which property holds and appurtenant property right issued in the name of H.P. Stewart, for the
15 irrigation of 17.5 acres, more precisely described as: 13.25 acres in the NE $\frac{1}{4}$ SE $\frac{1}{4}$, Section 20,
16 and 4.25 acres in the NW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 21, is HEREBY CORRECTED and AMENDED to
17 provide that Little Creek is the correct source for the right established by H.P. Stewart, but in all
18 other respects, including continuance of the priority date established for such water right, said
19 Decree is ratified and confirmed.
