Final Order

Hearing and Appeal Rights

Under the provisions of ORS 537.170 and ORS 537.622, the applicant may request a contested case hearing by submitting the information required for a protest under ORS 537.153(6) or ORS 537.621(7) to the Department within 14 days after the date of mailing of this order as shown below. If a contested case hearing is requested, the Department must schedule one. In the contested case hearing, however, only those issues based on the modifications to the Proposed Final Order may be addressed.

ORS 536.075 allows for additional appeal rights for other than contested case. This is a Final Order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This statement of judicial review rights does not create a right to judicial review of this order, if judicial review is otherwise precluded by law. Where no changes have been made to a Proposed Final Order on a water right application and no protests have been filed during the protest period, the Final Order is not subject to judicial review.

Application History

On April 24, 2008, McKee Family Ltd Partnership submitted an application to the Department for a water use permit. The Department issued a Superseding Proposed Final Order on October 6, 2009. The protest period closed November 20, 2009, and no protest was filed.

The proposed use would not impair or be detrimental to the public interest, but the Department's continuing evaluation reveals that the Superseding Proposed Final Order requires modification to correctly describe the period of use for irrigation from live flow and include an additional condition.

As noted in the March 6, 2009 Initial Review, the irrigation season for the use of live flow will be limited by the Yamhill River Decree, which allows the use of water for irrigation from April 1 through September 30. However, the Superseding Proposed Final Order incorrectly described the irrigation season from runoff as March 1 through April 30. The correct irrigation season from runoff, as included in the attached permit, is April 1 through April 30.


The following condition, which was noted in the Initial Review but omitted from the Superseding Proposed Final Order, will be included in the attached permit:

Irrigation allowed shall be by drip irrigation or by an equally efficient method.

Order

Application S-87159 therefore is approved as proposed by the Proposed Final Order, and Permit S-54620 is issued as limited by the conditions proposed by the Proposed Final Order.
