SETTLEMENT AGREEMENT

This Settlement Agreement, ("Agreement") is dated as of January 27th, 2006 and is made by and among Robert L. and Robert C. Sheehy, Lloyd D. Reagan, Jack S. and Gloria D. Kleck nka Gloria D. Sheehy, Lyman F. Baker, Terry and Karen Mudd and Wright Hemp Hutchinson Ditch Improvement District (Protestants In the Matter of the Transfer Application T-8058 hereinafter Protestants and "the contest"), Michael A. Becker, and Oregon Water Trust (OWT). Protestants, Michael A. Becker, and OWT are herein sometimes referred to as the "Parties."

RECITALS

- A. OWT, on behalf of Becker, made an Application for Transfer of Water Right in August 1998. Protestants filed protests opposing the application. A contested case was held and on November 22, 2002 a Proposed Final Order was issued. Exceptions were filed by the Protestants and the Applicant filed responses to those exceptions.
- B. Protestants, Becker, and OWT wish to enter into a full and final settlement of all the issues raised in the contests and all the claims and allegations by Protestants contained therein.

NOW, THEREFORE, in consideration of their mutual promises as set forth in this Agreement, the receipt whereof is hereby acknowledged by the Parties, the Parties hereby agree as follows:

1. TERMS

- As of the Effective Date, Protestants hereby voluntarily dismiss without prejudice their contests and exceptions to T-8058. Upon issuance by the Oregon Water Resources Department ("OWRD") of the final order approving Application T-8058 in the form attached hereto as Attachment 1, Proponents and Protestants agree not to challenge or appeal the final order or this Agreement.
- 1.1 The Effective Date of this Agreement shall be the date when the Final Order has been signed by the OWRD.
- 1.2 The Parties agree under T-8058 the rate protected for instream use shall be as follows:

Certificate 81172 (see Attachment 3):

13.63 acres transferred from irrigation to instream converted to a rate of .17 to be used from June 1 through September 28 which in total does not exceed 3.0 acre foot duty (per annum) per acre.

Certificate 5811 (see Attachment 2):

9.7 acres transferred from irrigation to instream converted to a rate of .12 to be used each month from March 1 through October 31.

2. **NO ADDITIONAL TRANSFERS**

OWT and Becker agree to make no further applications to OWRD for transfer of Little Creek source waters or from its tributaries sooner than two years from the effective date of this Agreement.

3. **LIABILITY**

The Parties hereby release each other and each other's agents, witnesses, and affiants of any and all liability for actions, claims, statements and representations made related to the sale, purchase and transfer of the water rights and appurtenant property including but not limited to those statements made in the affidavits of cancellation, arising or accruing prior to the Effective Date of this Agreement.

4. **GENERAL PROVISIONS**

- 4.1 <u>Choice of Law</u>: This Agreement shall in all respects be interpreted, enforced, and governed by and construed in accordance with the laws of Oregon.
- 4.2 <u>Entire Agreement</u>: This Agreement will constitute the entire agreement among the parties with respect to the subject matter here as in all promises, representations, understandings, arrangements, and prior agreements relating to the subject matter are merged and superseded by this Agreement.
- 4.3 <u>Counterpart</u>: This Agreement may be executed simultaneously or with separate signature pages and in more than one counterpart, each of which will be deemed an original, and of which together shall constitute one and the same Agreement. Delivery of an executed signature page to this Agreement by facsimile transmission shall be as effective as delivery of a manually signed counterpart of this Agreement.
- 4.4 <u>Attorney Fees:</u> Each party shall be responsible for his/her/its attorney fees and costs in these matters. In any action to enforce this Agreement, the prevailing party shall be awarded its attorney fees, costs, and expenses at trial or upon appeal.

HISTORY OF THE CASE

On August 10, 1998, applicant Oregon Water Trust on behalf of landowner, Michael Becker, filed transfer application T-8058 with the Oregon Water Resources Department (OWRD or the Department), proposing to modify water rights evidenced by Certificate C-6236 and cancel supplementary rights evidenced by C-6236 and C-5811. The applicants subsequently filed amendments to the transfer application on May 24, 1999 and again on June 13, 2000. Protests to the application were timely filed by protestants Robert L. and Robert C. Sheehy (Robert C. Sheehy is now deceased and is succeeded in interest by Dona G. Sheehy); Lloyd D. Reagan; Jack S. and Gloria D. Kleck nka Gloria D. Sheehy; Lyman E. Baker; Robert L. Mudd (now deceased, succeeded in interest by Terry and Karen Mudd); and the Wright Hemp Hutchinson Ditch Improvement District (hereafter referred to collectively as "protestants").

The Department initiated a contested case by its Notice of Hearing and Prehearing Conference dated October 3, 2000.

On April 24 and 25, 2002, a contested case hearing was held in this matter at the Union City Hall, Union, Oregon. The applicant Oregon Water Trust appeared through and with Attorney Douglas MacDougal. The Department appeared through and with Assistant Attorney General Shannon O'Fallon. Protestants appeared through and with attorney Laura A. Schroeder. Witnesses presented testimony through written direct

examination and rebuttal subject to cross-examination at hearing. Written closing arguments were submitted.

A proposed order was issued on November 22, 2002. Exceptions were filed by the Protestants and the Applicant filed responses to those exceptions.

Concurrent with these transfer proceedings, the parties stipulated to voluntary cancellation of portions of the rights subject to transfer. Pursuant to a stipulated agreement reached by the parties to the cancellation proceedings, The Oregon Water Trust amended its transfer application to reflect the voluntary reduction of the rights to be transferred instream.

Pursuant to ORS 183.415(5), the parties entered into a Settlement Agreement that resolves the protests to transfer application T 8058. Based on the Agreement, which is incorporated herein, and the record in this matter, the quantities to be transferred for the protection of instream flows are as follows:
