(1) The Final Decree in the Matter of the Determination of the Relative Rights of the Various Claimants to the Waters of the Umatilla River and its Tributaries, a Tributary of the Columbia River, in Umatilla County, Oregon, entered in the matter on the 9th day of September, 1916, shall be amended as follows:

A. The reference in the above-referenced Decree to that portion of the water rights adjudicated to Carl A. Johnson stated as "1 acre in NE $\frac{1}{4}$ SE $\frac{1}{4}$ " of Section 4, Township 2 South, Range 32, E.W.M., in Umatilla County, Oregon, is changed to "1 acre in SE $\frac{1}{4}$ SE $\frac{1}{4}$ " of said township and range.

1 B. The reference in the above-referenced Decree to that
2 portion of the water rights adjudicated to Perry Knotts as "3 acres
3 in NW $\frac{1}{4}$ NW $\frac{1}{4}$ " of Section 10, Township 2 South, Range 32, E.W.M., in
4 Umatilla County, Oregon, is changed to "3 acres in SE $\frac{1}{4}$ NW $\frac{1}{4}$ " of said
5 township and range.

6 C. For clarity's sake, attached hereto as Exhibit A is a
7 photocopy of said 1916 Decree showing the locations in the Decree
8 which are being amended hereby.

9 D. In all other respects, said 1916 Decree shall remain
10 unchanged by this Judgment.
