Hi Doug, Marc, and Tony,

On October 1, 2010, Marc Norton completed a public interest review for this application which proposed the appropriation of 0.02 CFS from a well (UMAT 3613) in Umatilla Drain Basin for irrigation of 1.64 acres from March 1 through October 31.

The Department issued an IR on October 29, 2010 based on review of 0.02 CFS, as per requested in the application form.

On November 8, 2010, the Department received a letter from the applicants requesting a rate of 0.065 CFS to 0.067 CFS in order to efficiently operate the distribution system. As you may recall, ORS 537.621(4) allows the applicant the opportunity to request a rate and/or duty that is higher than the general basin-wide standard by submitting information that demonstrates the need for the higher rate and/or duty.

Per Tim Wallin, an increase in rate alone with the annual volume remaining the same does not constitute an expansion.
