Dear Michael and Kristine LaGrande:

The Department has received the Ownership Update form you submitted. This form is for use on perfected rights that have been issued a Certificate of Water Right. The applications shown on the form have not yet received a permit and must be assigned to place them in your name. The assignment places the application or permit in your name. This is important because a permit is not a finished or perfected water right. The Department will need to be able to correspond with the valid permit holder to ensure that a permit can be issued, that conditions set forth in the permit are met, and the Claim of Beneficial Use are submitted timely, to facilitate the issuance of the final Certificate of water right. It is important to note that only the permit holder has the authority to request changes or other actions on a permit. Failing to assign the permit could eventually lead to cancellation proceedings being initiated without your knowledge.

Two Requests for Assignment are enclosed for your use, if you are the owner of the lands covered by the above referenced water right permit. One form is to be used if the permit holder(s) of record are available to sign the form. The second form is for use when the permit holder of record is not available to sign, and proof of ownership of the affected lands is submitted to make the assignment. *You will need to submit a separate form and fee for each right to be assigned.*

# Certificate of Water Right Ownership Update

## NOTICE TO SELLERS & BUYERS:

By law, all water belongs to the public (ORS 537.110). In almost every instance, a permit or water right certificate from the Water Resources Department is needed before using, diverting or storing water (ORS 537.130). However, most domestic wells do not require water rights. A certificate of water right stays with the land. In order to keep track of water right ownership, the Department requests that this form be submitted to the Department. *If for multiple rights, a separate form for each right will be required.*

Water that has been used for a long time in one place or that involves a water structure (like a dam) that already exists is no guarantee that there is a water right which would allow the water use to continue.
