## CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** JOHN H. DERKSEN & OTTO L. WEINHOLD

of Rt. 4, Box 75-J, Salem, State of Oregon, 97302, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of unnamed spring

a tributary of Battle Creek for the purpose of domestic use for three families, stock use only during the irrigation season of each year, and the irrigation of 10.7 acres under Permit No. 1927 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 2, 1914 that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.16 cubic foot per second, being 0.014 c.f.s. for domestic, 0.013 c.f.s. for stock, and 0.133 c.f.s. for irrigation

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$  SW $\frac{1}{4}$ , Section 30, T. 8 S., R. 2 W., W. M., 1650 feet North and 760 feet West from the NE Corner, Delaney DLC 64

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Domestic, Stock, & 10.4 acres SE $\frac{1}{2}$  SW $\frac{1}{4}$   
0.3 acre SW $\frac{1}{4}$  SE $\frac{1}{4}$   
Section 30  
T. 8 S., R. 2 W., W. M.


This certificate describes that portion of the water right confirmed by the prior certificate recorded at page 20787, Volume 15, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered on September 23, 1966, approving transfer application No. D-120 as well as to confirm the change in character of use and place of use approved by the same order and supersedes certificate 20787.

The issuance of this superseding certificate does not confirm the status of the water right in reference to ORS 540.610.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described and is subject to the existing minimum flow policies established by the Water Policy Review Board.
