The following applicant has submitted a response to the Mitigation Obligation.

Application G-17341 Cascade Academy of Central Oregon

Use: commercial uses; irrigation of 3.0 acres

Rate of use: 0.05 CFS, being 0.04 CFS for irrigation and 0.01 CFS for commercial use

Maximum Volume of use: 15.75 AF

Mitigation Obligation: 6.4 AF (5.4 AF for irrigation, 1.0 AF for commercial)

irrigation: 3.0 acres * 1.8/acre = 5.4 AF

commercial: 7 gpm for 5 days/week Sept-June = 215 days → 7 gpm * 215 days * 1 AF/325851 gals =

6.65 AF * 15% → 1.0 AF

Period of use: commercial – September 1 through June 30; irrigation – April 1 through October 31

Zone of Impact: General Zone of Impact

Proposed Source of Mitigation will be: purchase mitigation credits

The information provided by the applicant meets the criteria to continue the water right application review.
