This is in reply to your letter of May 22nd, with which you returned to this office Permit No. 8091 that has been issued to Mr. L. W. Smith.

The statement in the body of the application that construction would be commenced on or before October 1st, 1926, was made by the applicant but is not binding upon him. The time limit for beginning is as fixed on the last page and is September 1st, 1928.

This permit is for irrigation of 127.41 acres. Your letter states that the ditch has been reconstructed and water used on the land during 1927, but does not state that all of the land has been irrigated. I am considering your letter as Notices of Beginning and Completion of Construction, and as soon as all the land is irrigated you may submit the Notice of Complete Application of Water on the blank enclosed.

If you wish to have this water right appear on our records in your name, you should secure an assignment of this permit from Mr. Smith and forward the same to this office. The enclosed form may be used for this purpose, and the fee required for recording an assignment on this blank is \$1.00.

The permit is being returned to you and should be retained as evidence of your right until after the issuance of the certificate.
