 Re: Correction Certificate 86671 to supersede Certificate 48649

1. Certificate 45149 was issued January 31, 1978, to describe the portion of the water right confirmed by Certificate 24411 NOT modified by the provision of an order entered December 14, 1977, recorded at Special Order Volume 30, Pages 182-183, approving Transfer Application T-3747. The description of the lands was based on the original 1956 Final Proof Survey map for (Application S-24436/Permit S-19266)
2. On July 17, 1980, the Department adopted a corrected map to supersede the Final Proof Survey for the water right (Application S-24436/Permit S-19266). The map re-described all of the lands originally under Certificate 24411, which by that time were included in both T-3747 (Special Order Volume 30, Pages 182-183) and Certificate 45149.
3. On August 15, 1980, an order was issued (Special Order Volume 33, Pages 602-603) approving T-4279 and cancelling Certificate 45149. The portions of the right involved in T-4279, as well as the remaining portions, were described in conformity with the 1980 map.
4. On October 26, 1979, Certificate 48649 was issued to confirm the change in point of diversion approved under T-3747. It incorrectly described the place of use based on the old description in the T-3747 order, rather than with the re-description of the lands in the 1980 map.
5. Certificate 48649 described the place of use follows:

6. The 1980 map re-described the place of use as follows:

7. Certificate 86671 is being issued to supersede Certificate 48649 and to correct the place of use so that it is consistent with the re-description of the right in the 1980 map.
