**PUBLIC INTEREST PRESUMPTION; GROUNDWATER**

**OAR 690-310-130 (1)** *The Department shall presume that a proposed groundwater use will ensure the preservation of the public welfare, safety and health as described in ORS 537.525.* Department staff review ground water applications under OAR 690-310-140 to determine whether the presumption is established. OAR 690-310-140 allows the proposed use be modified or conditioned to meet the presumption criteria. **This review is based upon available information and agency policies in place at the time of evaluation.**

B3. Ground water availability remarks: SEVERAL HIGH YIELDING (1800 – 2600 GPM) WELLS ARE LOCATED OR PLANNED IN THE VICINITY OF THE WELLS ON THIS APPLICATION. TWO NEARBY WELLS HAVE RELATIVELY LONG-TERM MEASUREMENT RECORDS. DESC 53516 HAS BEEN MEASURED SINCE 1993 AND SHOWS A SLIGHT, STEADY DECLINE (3.5 FEET) OVER THE PERIOD OD RECORD. ANOTHER NEARBY WELL DESC 55145 HAS A SIMILAR TREND AND HAS DECLINED ABOUT 2.5 FEET SINCE 2004.

C6. **SW / GW Remarks and Conditions** GROUND WATER FLOW DIRECTION IS UNCERTAIN, BUT MAY BE TOWARDS THE NORTHWEST (MILLICAN VALLEY). INTERFERENCE WITH THE NEAREST STREAM (CAMP CREEK) IS HIGHLY UNLIKELY GIVEN THE HYDRAULIC HEAD RELATION AND THE NEARBY OCCURRANCE OF EARLY TO MIDDLE TERTIARY GEOLOGIC UNITS THAT ARE TYPICALLY CHARACTERIZED AS BOUNDARIES TO REGIONAL GROUND WATER FLOW.

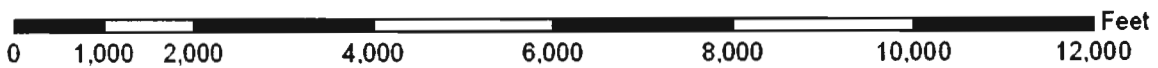
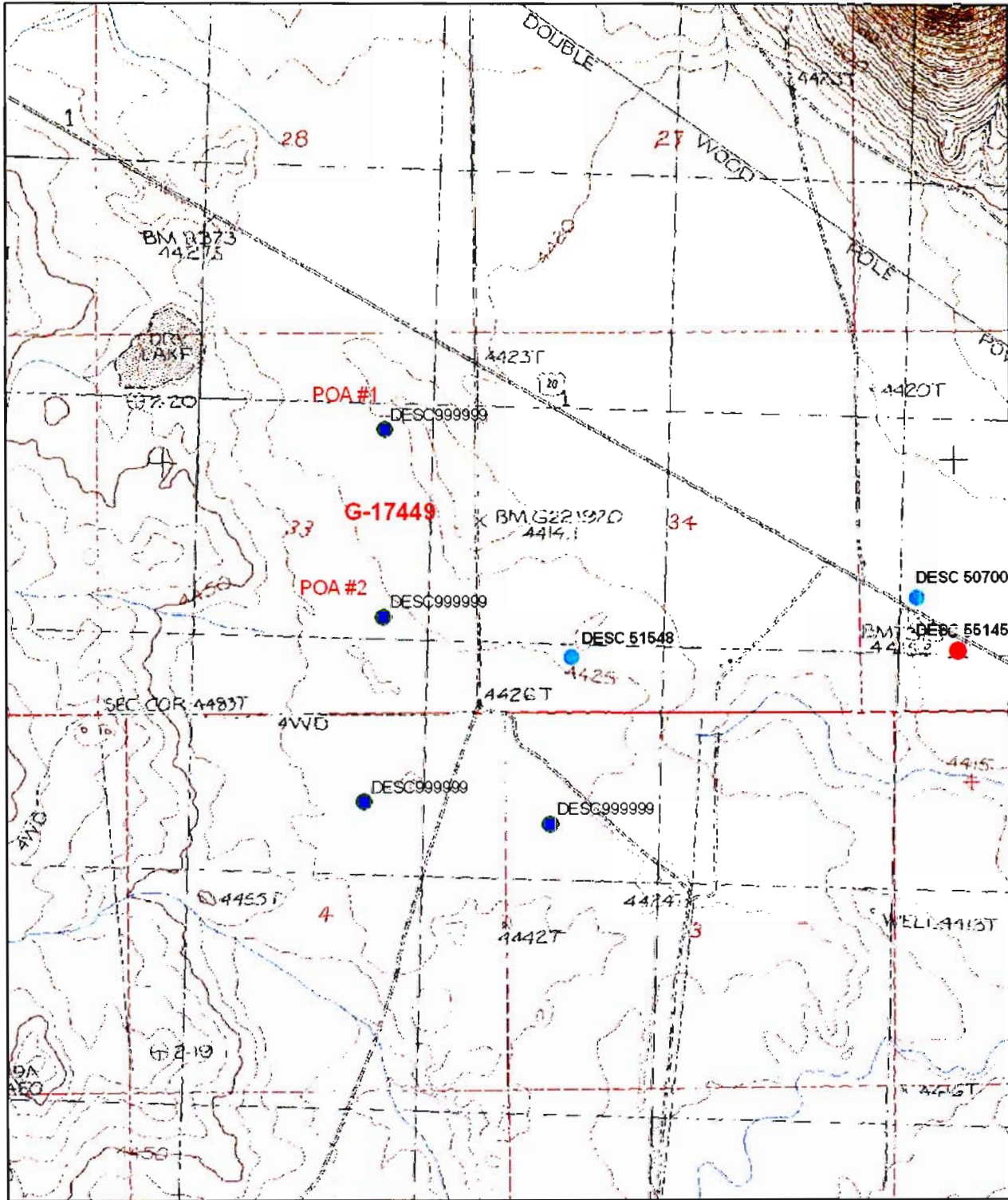

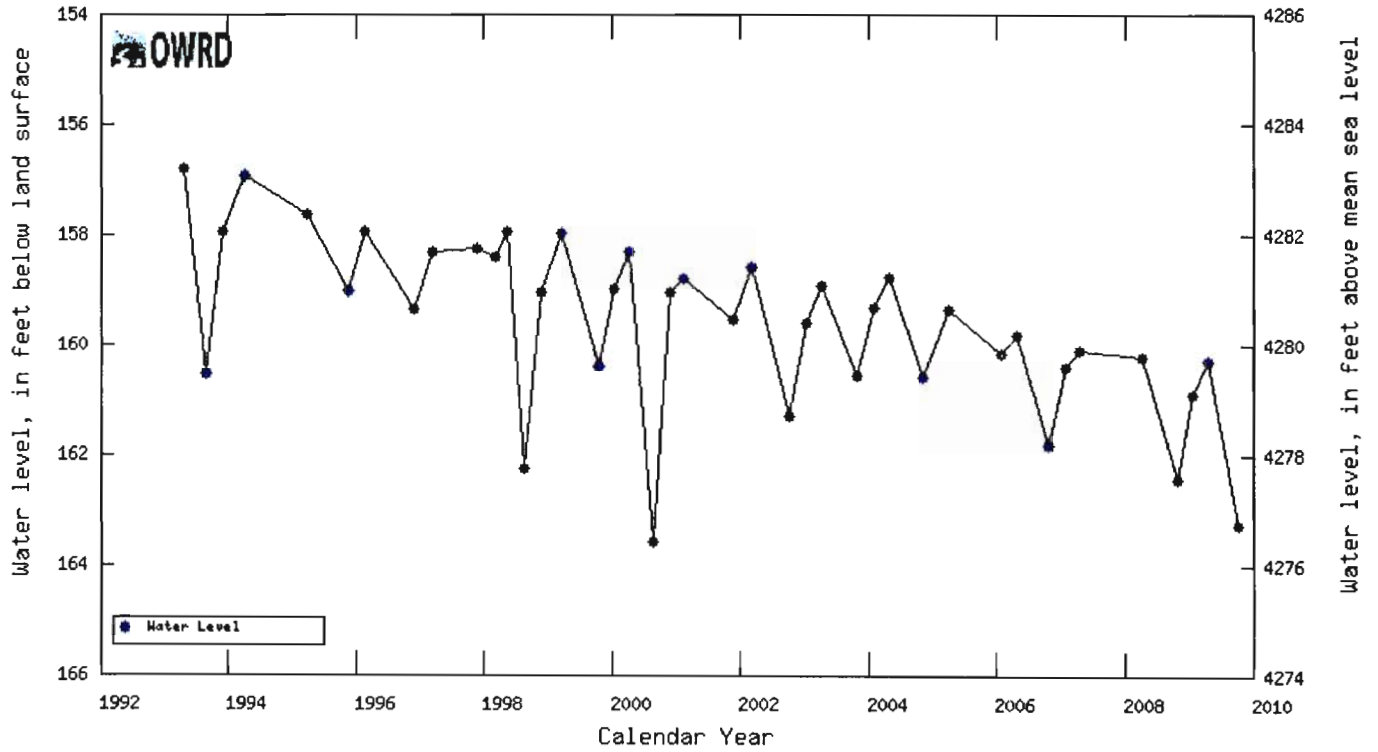
