Dear Mr. Sauter,

The water availability model for the above mentioned applications (WAB 31530902) shows that there is no water available in the Applegate River for the purposed use (human consumption) during the months of February thru April. The perennial in-stream rights for the Applegate River are generally met year round, as the river's flow is controlled by water released from the Applegate Dam. The purposed human consumption is for a very small amount of water (0.005 cfs) and will have no quantifiable affect on the river's overall flow. There appears to be adequate water available in the river for the purposed use.
