PUBLIC INTEREST PRESUMPTION; GROUNDWATER

OAR 690-310-130 (1) *The Department shall presume that a proposed groundwater use will ensure the preservation of the public welfare, safety and health as described in ORS 537.525.* Department staff review ground water applications under OAR 690-310-140 to determine whether the presumption is established. OAR 690-310-140 allows the proposed use be modified or conditioned to meet the presumption criteria. **This review is based upon available information and agency policies in place at the time of evaluation.**

B3. **Ground water availability remarks:** The nearby observation wells (MALH 220 and 122) penetrate an overlying alluvial aquifer, so they are not especially useful to evaluate groundwater availability for the deeper aquifer (Glenns Ferry Formation) penetrated at this well. It appears that there is limited but increasing local development of the deeper aquifer for irrigation in this area.

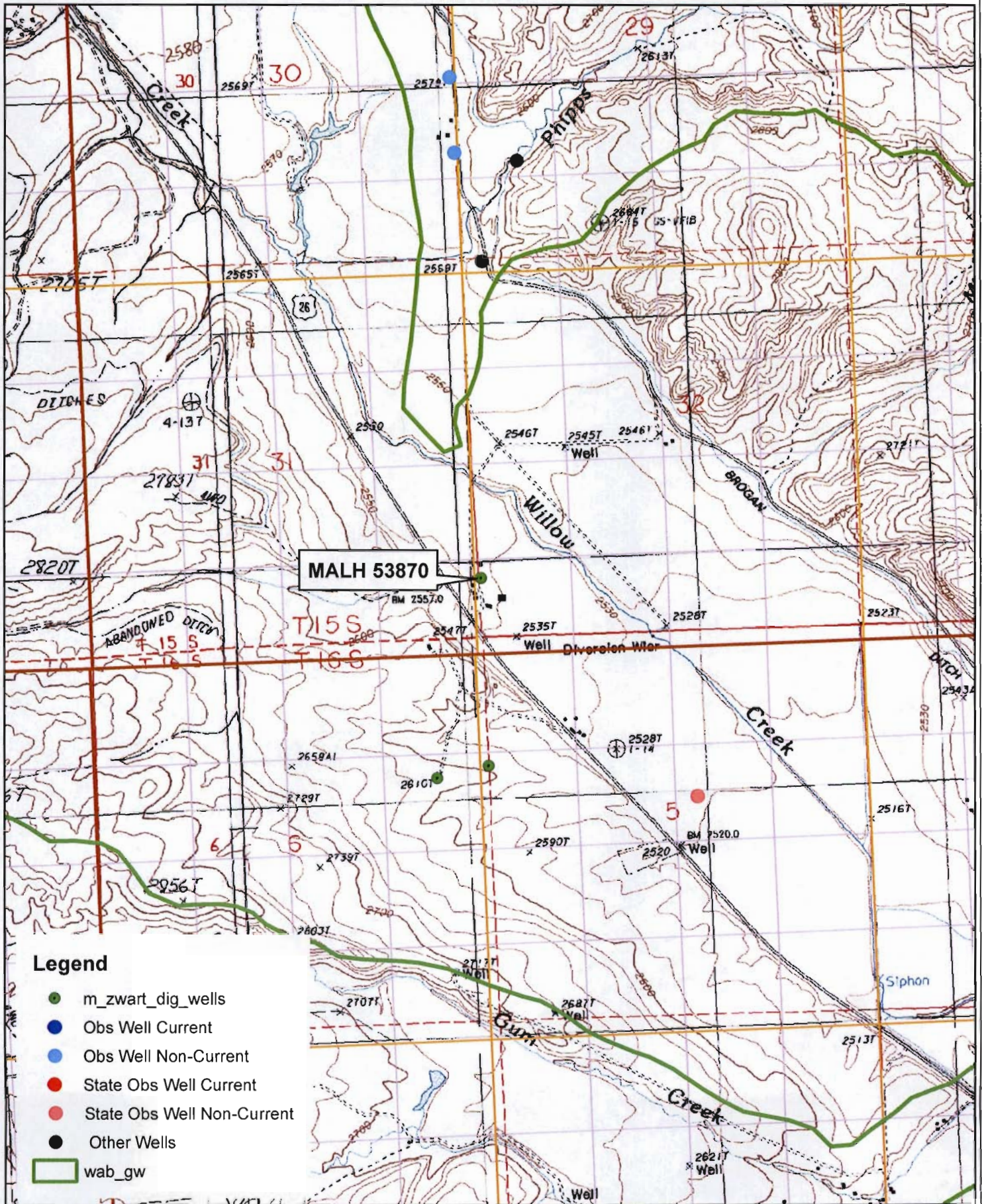
