Pursuant to ORS 540.510 to 540.530, after notice was given and no objections were filed, and finding that no injury to existing water rights would result, this order approves, as conditioned or limited herein, TRANSFER 9111 submitted by

The right to be modified, as evidenced by a portion of Certificate 42198, was perfected under Permit 34633 with a date of priority of AUGUST 29, 1969. The right allows the use of HORSESHOE LAKE, a tributary of the WILLAMETTE RIVER, for IRRIGATION OF 4.0 ACRES. The amount of water to which this right is entitled is limited to an amount actually beneficially used and shall not exceed 0.05 cubic foot per second, if available at the authorized point of diversion: SW% NW%, AS PROJECTED WITHIN J. MOORE DLC 59, SECTION 22, T 11 S, R 4 W, W.M.; 2050 FEET SOUTH AND 1480 FEET WEST FROM THE NW CORNER OF W. MOORE DLC 60, or its equivalent in case of rotation, measured at the point of diversion from the source.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, is limited to ONE-EIGHTIETH of one cubic foot per second per acre or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre-feet for each acre irrigated during the irrigation season of each year.

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2).

Pursuant to ORS 536.075 and OAR 137-004-080 and OAR 690-01-005 you may either petition for judicial review or petition the Director for reconsideration of this order.


