This letter is to inform you that your project has received Development Review approval from the City of Hillsboro Planning Department, and drawings may submitted to the Building Inspection Department for building permit approval. However, the following requirements outlined below <u>must be resolved prior to, or at the time of building permit submittal.</u> In addition, prior to building permit submittal, please submit a brief written response to each of the following comments to the Planning Department. Any revisions necessitated by the below requirements should be shown on a revised set of plans, a copy of which should be submitted to the Planning Department as well.

BUILDING DEPT. Mike Gieszler - 681-6106

1. Provide accessible route to the public way from the sales trailer.

ENGINEERING DEPT. Roy Gibson 681-6148

- 2. Morse Brothers will need to successfully obtain required DEQ permits for the plant operation including storm water discharge and air contaminant etc. as needed.
- 3. Construct ½ street improvements per City of Hillsboro industrial roadway section to centerline of right-of-way. Improvement to include curb/gutter, industrial street section (provide design), storm sewer, planter strip, sidewalk, option "B" street lights. Taper at each end per AASHTO standards. Dedicate right-of-way per industrial street standard on Wood Street.
- 4. Provide on-site water quality service (private system) per Clean Water Services standards.
- All storm sewer constructed to serve SW Wood Street to be public constructed to City of Hillsboro and CWS standards.
- All on-site storm and san. sewer to be constructed per plumbing code and shall be privately owned and maintained. No private system shall be constructed in the public right-of-way except for direct connection to the public line.

- 7. The building permit application submittal shall include notes on the site, landscaping, or utility plans and/or building elevations, and/or a narrative, clearly identifying how the Development Review comments have been addressed.
- 8. Applicant should revise the landscape plan to include additional street trees within the SW Wood Street ½ street improvement. These trees should be spaced at 35 feet on-center and should be either the Red Sunset Maple listed in the plant list or another variety of street tree such as Littler-leaf Linden or Raywood Ash. These trees should be planted within the planting strip located between the sidewalk and the curb and should be planted with root retainers to prevent damage to the sidewalk and curbs. The existing Red Sunset Maple trees shown behind the sidewalk on the west side of the western most driveway onto SW Wood Street should be changed to the Scotch Pines and should be spaced at a similarly to the pines shown between the two driveways. A revised landscape plan should be submitted with the building permit set for review and approval by the Planning Department.
- 9. Sign permits are required for all exterior signs on the building and freestanding. These permits are issued from the Planning Department.
