## Final Order

Hearing and Appeal Rights

Under the provisions of ORS 537.170 and ORS 537.622, the applicant may request a contested case hearing by submitting the information required for a protest under ORS 537.153(6) or ORS 537.621(7) to the Department within 14 days after the date of mailing of this order as shown below. If a contested case hearing is requested, the Department must schedule one. In the contested case hearing, however, only those issues based on the modifications to the Proposed Final Order may be addressed.

ORS 536.075 allows for additional appeal rights for other than contested case. This is a Final Order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This statement of judicial review rights does not create a right to judicial review of this order, if judicial review is otherwise precluded by law. Where no changes have been made to a Proposed Final Order on a water right application and no protests have been filed during the protest period, the Final Order is not subject to judicial review.

## Application History

On July 1, 2011, Lowell Patton submitted an application to the Department for a water use permit. The Department issued a Proposed Final Order on May 1, 2012, recommending approval of the application contingent upon the submission of evidence demonstrating compliance with well construction standards for Well A-1 (CLAC 4075), and permit recording fees in the amount of \$400. The protest period closed June 15, 2012, and no protest was filed.

On May 17, 2012, the Department reviewed the Water Supply Well Report for a new well drilled to replace CLAC 4075, which was assigned CLAC 68713, and determined the well meets construction standards.

On June 25, 2012, the Department received \$400 for permit recording fees.

The proposed use would not impair or be detrimental to the public interest, but the Department's continuing evaluation reveals that the Proposed Final Order requires modification to include the well location of the replacement well, CLAC 68713.

## Order

Application G-17478 therefore is approved with the above modifications to the Proposed Final Order, and Permit G-16945 is issued as limited by the conditions set forth therein.
