

Abstract of Permit

This is to certify that I have examined APPLICATION 59900 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Lookingglass-Olalla Water Control District of General Delivery, Tennille, Oregon 97481, for the use of the waters from enlargement of Ben Irving Reservoir to be appropriated under Application R-60572, Permit R-8444, a tributary of Berry Creek, a tributary of Olalla Creek, for the PURPOSE of irrigation, supplemental irrigation, domestic use for two families including irrigation of not to exceed one-half acre lawn and noncommercial garden each, and general park uses, being 5,770 acre-feet for irrigation and supplemental irrigation, 4.0 acre-feet for domestic use, and 4.0 acre-feet for general park uses; that the PRIORITY OF THE RIGHT dates from March 17, 1981, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 5,778 acre-feet stored water only.

The POINT OF DIVERSION is to be LOCATED: 944 feet North and 266 feet West from the Center Quarter Corner of Section 20, being within the SE 1/4 NW 1/4 of Section 20, Township 29 South, Range 7 West, WM, in the County of Douglas.

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before July 30, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1984.

Complete application of the water to the proposed use shall be made on or before October 1, 1985.
