Dear Mr. Layman:

I have your letter of March 15th and note your proposal to amend the permit heretofore issued to the city of Dundee.

If I was called upon to interpret the permit as issued I would feel inclined to give it a broad interpretation which would allow the city the right to furnish water for domestic supplies to any one along the line. However, if you feel that there is any doubt as to the city's right I would suggest that you file a new application for permit to appropriate the same water for domestic use for the purpose of furnishing those living near your pipe line. I doubt if this office has authority to amend the original permit as you suggest.

The notices transmitted with your letter appear to be in proper form and have been placed on file.

I am returning original permit No. 5922 herewith.

Dear Sir:-

Enclosed find Notice of beginning of construction and Notice of completion of construction of the works specified in your permit No. 5932.

Various persons just outside the City of Dundee would like to buy water from the municipal water system, but there is a question in the minds of the officers of the City, whether the permit is broad enough to permit the taking of water for sale outside the corporate limits. It seems to me that such question could be eliminated by adding the words "and vicinity", after the word Dundee in paragraph 5 of the application; by adding the same words after the word Dundee in paragraph 11 of the application, and also, by adding the words, "and for domestic purposes outside the City of Dundee", after the word "purposes" in the permit signed by Mr. Copper on page 4.

I send herewith the original application with the idea that you will add the words suggested if you think proper. If you think it better to file an amended application, please send the necessary blanks and advise whether the map may be detached from the original application and attached to such amended application.
