

Township 11S, Range 5W, Willamette Meridian



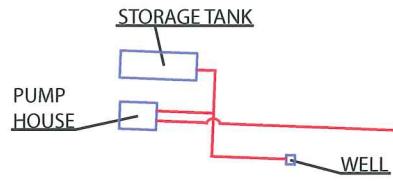
