Per ORS 390.835, the Ground Water Section is able to calculate ground water interference with surface water that contributes to a Scenic Waterway. The calculated interference is distributed below.

Per ORS 390.835, the Ground Water Section is unable to calculate ground water interference with surface water that contributes to a scenic waterway; therefore, the Department is unable to find that there is a preponderance of evidence that the proposed use will measurably reduce the surface water flows necessary to maintain the free-flowing character of a scenic waterway.

PUBLIC INTEREST PRESUMPTION; GROUNDWATER

OAR 690-310-130 (1) *The Department shall presume that a proposed groundwater use will ensure the preservation of the public welfare, safety and health as described in ORS 537.525. Department staff review ground water applications under OAR 690-310-140 to determine whether the presumption is established. OAR 690-310-140 allows the proposed use be modified or conditioned to meet the presumption criteria. B3. Ground water availability remarks: There is only one local high-production well constructed in the aquifer proposed (BAKE 51846/BAKE 51888). The construction of this well suggests that the proposed well here may need to be several hundred feet deep in order to produce the desired quantity of water.

Basis for aquifer hydraulic connection evaluation: The nearby reach of Sutton Creek is developed in Quaternary alluvium. Water-bearing zones in Tertiary sedimentary rocks likely discharge to the alluvium where they may be in contact, resulting in indirect hydraulic connection and diffuse interference with the creek. The proposed seal depth, to elevation 3582±, will be sufficient to limit this indirect connection, and also any direct hydraulic connection resulting from sedimentary rocks possibly subcropping in the bed of the creek. These rocks are mapped as dipping to the north, which would likely ensure that hydraulic connection is minimized with more distant reaches of Sutton Creek.

Water Availability Basin the well(s) are located within: Sutton Cr > Powder R at mouth (30920331).

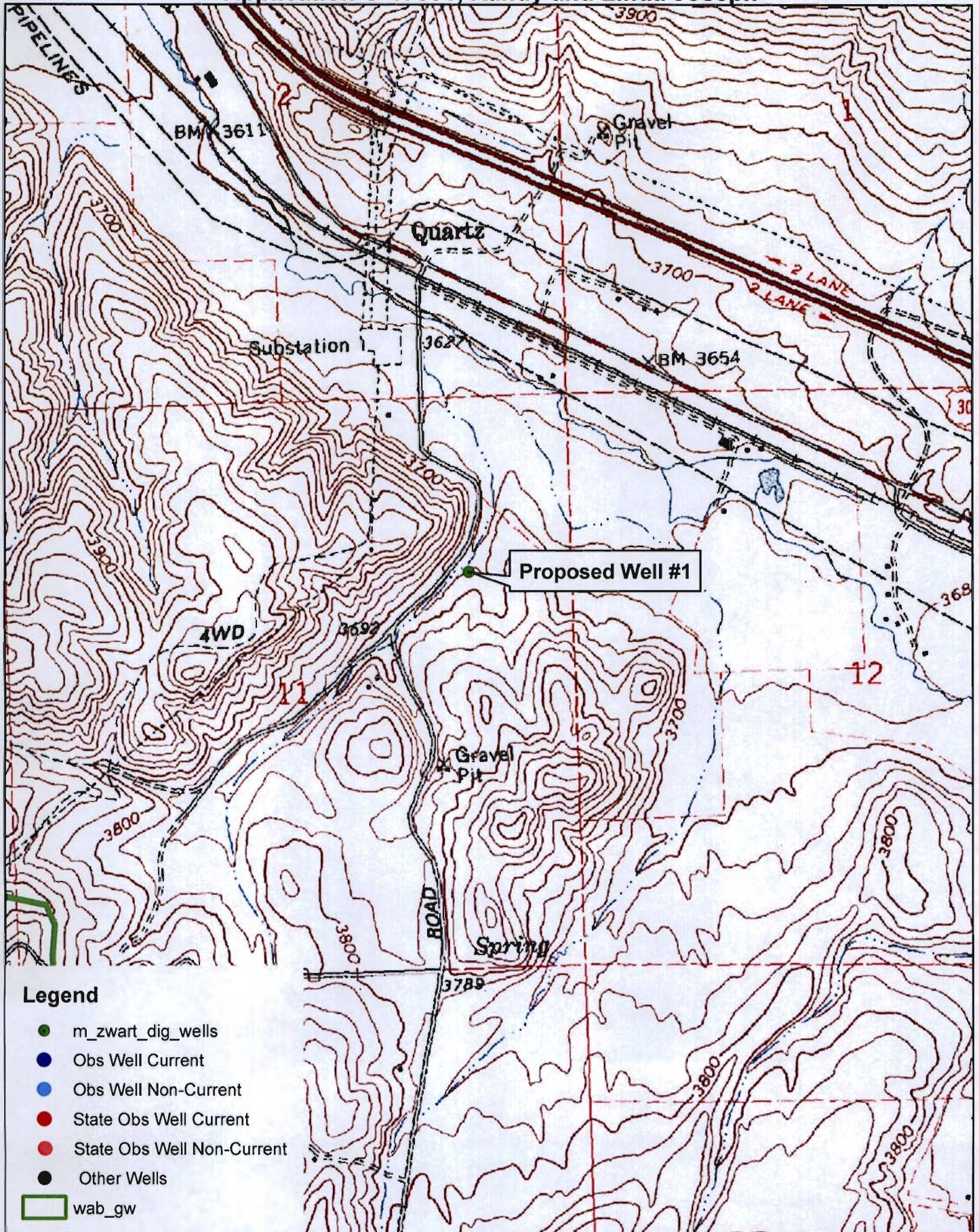
