The GENERAL FINDINGS OF FACT of the FINAL ORDER OF DETERMINATION is incorporated as if set forth fully herein.

A. FINDINGS OF FACT

- 1. For purposes of the Final Order of Determination and any subsequent certificates, OWRD bifurcated a portion of Claim 12 and labeled it Claim 731. OWRD bifurcated Claim 12 after Claim 12 was withdrawn from the Office of Administrative Hearings. Claim 731 includes property appurtenant to Claim 12 that was transferred to Jeff and Lynda Hunt and Richard and Jennifer Sanford on December 18, 1998, including property within the NESW, NWSW, NESE, and NWSE of Section 13, and the NESE of Section 14, Township 30 South, Range 10 East, W.M. The rest of the Claim 12 claim area remains a part of Claim 12.
- 2. On November 19, 1990, DIANE TAYLOR OF BEHALF OF DENNIS RANCH timely submitted a Statement and Proof of Claim (Claim 12) to the Oregon Water Resources Department (OWRD) pursuant to ORS Chapter 539 in the Klamath Basin Adjudication, as a non-Indian successor to allotted Klamath Reservation lands, claiming a vested Indian reserved water right (Walton claim) under the Treaty of October 14, 1864, 16 Stat. 707.
- 3. Claim 12 was submitted for a total of 17.9 cfs of water for irrigation of 1035.2 acres and 0.01 cfs for livestock watering for a maximum of 400 head. The claimed sources are Irving Creek and Jackson Creek, both tributaries of the Williamson River, and the Williamson River, tributary to Upper Klamath Lake. The claimed period of use is "Apr. 1 Nov. 1." The claimed priority date is October 14, 1864.
- 4. DIANE F. TAYLOR signed Claim 12 attesting that the information contained in the claim is true.
- 5. The claim was subsequently transferred to the G BAR W LAND AND CATTLE COMPANY. See LETTER, May 24, 1993 (Claim # 12, Pages 040-041).

- 6. On October 4, 1999, following investigation of the evidence submitted, the Adjudicator issued a Summary and Preliminary Evaluation of Claims (Preliminary Evaluation) stating the claim was approved for livestock watering and irrigation, but for fewer acres and a smaller quantity of water, and with longer seasons of use than claimed.
- 7. On December 18, 1998, the title to property appurtenant to Claim 12 within the NESW, NWSW, NESE, and NWSE of Section 13, and the NESE of Section 14, Township 30 South, Range 10 East, W.M. (partial listing) was transferred from G BAR W LAND AND CATTLE COMPANY to JEFF AND LYNDA HUNT, AND RICHARD AND JENNIFER SANFORD (Claimants). See COUNTY OF KLAMATH RECORDS, Vol. M98, PAGES 27738 27740 (May 11, 1998).
- 8. On April 19, 2000, Claimant JEFF G. HUNT timely filed Contest 29 to the Preliminary Evaluation of Claim 12.
- 9. On May 4, 2000, G BAR W LAND AND CATTLE COMPANY timely filed Contest 1789 to the Preliminary Evaluation of Claim 12.
- 10. On May 4, 2000, Steven Lawrence, James B. Lawrence and John H. Lawrence timely filed Contest 1786 to the Claim and/or Preliminary Evaluation of Claim 12.
- 11. On May 8, 2000, the following parties, hereinafter collectively referred to as the "Klamath Project Water Users," filed Contest 3434: Klamath Irrigation District, Klamath Drainage District, Tulelake Irrigation District, Klamath Basin Improvement District, Ady District Improvement Company, Enterprise Irrigation District, Klamath Hills District Improvement Co.¹, Malin Irrigation District, Midland District Improvement Company, Pine Grove Irrigation District, Pioneer District Improvement Company, Poe Valley Improvement District, Shasta View Irrigation District, Sunnyside Irrigation District, Don Johnston & Son, Bradley S. Luscombe, Berlva Pritchard², Don Vincent³, Randy Walthall, Inter-County Title Co., Winema Hunting Lodge, Inc., Van Brimmer Ditch Co., Plevna District Improvement Co., and Collins Products, LLC.
- 12. On May 8, 2000, the United States of America timely filed Contest 3718 to the Claim and/or Preliminary Evaluation of Claim 12.
- 13. On May 8, 2000, the Klamath Tribes timely filed Contest 4074 to the Claim and/or Preliminary Evaluation of Claim 12.
- 14. On May 8, 2000, WaterWatch of Oregon, Inc. filed Contest 2817 to the Claim and/or Preliminary Evaluation of Claim 12.

Klamath Hills District Improvement Company voluntarily withdrew from Contest 3434 on January 16, 2004. See VOLUNTARY WITHDRAWAL OF CONTEST BY KLAMATH HILLS DISTRICT IMPROVEMENT COMPANY

Berlva Pritchard voluntarily withdrew from Contest 3434 on June 24, 2002. See NOTICE OF WITHDRAWAL

Don Vincent voluntarily withdrew from Contest 3434 on November 29, 2000. *See* NOTICE OF WITHDRAWAL OF CLAIMANTS.

- 15. These matters were referred to the Office of Administrative Hearings for a contested case hearing which were designated as Case 163.
- 16. On February 20, 2003, WaterWatch of Oregon, Inc. withdrew Contest 2817. See WATERWATCH'S VOLUNTARY WITHDRAWAL OF CONTEST 2817 (Feb. 20, 2003).
- 17. On February 25, 2003, Steven Lawrence, James B. Lawrence, John H. Lawrence withdrew Contest 1786. See Voluntary Withdrawal of Contest by Steven Lawrence, James B. Lawrence, and John H. Lawrence (Feb. 25, 2003).
- 18. On July 14, 2003, G Bar W Land and Cattle Company withdrew Contest 1789. See LETTER Re: Case No.163, Claim No. 12 and Contest of Preliminary Evaluation (July 17, 2003).
- 19. On August 13, 2004, G Bar W Land and Cattle Company, Richard Sanford, Jennifer Sanford, Jeff Hunt, Lynda Hunt, OWRD, the Klamath Project Water Users, the United States of America, and the Klamath Tribes, executed a STIPULATION TO RESOLVE CONTESTS (Settlement Agreement) thereby resolving all the remaining contests to Claim 12.
- 20. On August 18, 2004, the Adjudicator withdrew Case 163 from the Office of Administrative Hearings.
- 21. The terms of the Settlement Agreement specify the water right claim is to be adjudicated to two separate ownership groups, being (1) G BAR W LAND AND CATTLE CO, and (2) JEFF AND LYNDA HUNT, AND RICHARD AND JENNIFER SANFORD. Therefore, OWRD finds it practical to bifurcate Claim 12; OWRD has retained the designation of Claim 12 for the portion of the claim pertaining to G BAR W LAND AND CATTLE COMPANY, and has designated the portion of the claim pertaining to JEFF AND LYNDA HUNT, AND RICHARD AND JENNIFER SANFORD as Claim 731.
- 22. OWRD finds that the season of use for livestock watering, January 1 to December 31, as stipulated in the Settlement Agreement is an impermissible amendment because it is an enlargement of the original claim; the Claimant claimed a season of use "Apr. 1 Nov. 1."

B. DETERMINATION

1. The Settlement Agreement executed between G Bar W Land and Cattle Company, Richard Sanford, Jennifer Sanford, Jeff Hunt, Lynda Hunt, OWRD, the Klamath Project Water Users, the United States of America, and the Klamath Tribes, is adopted and incorporated as if set forth fully herein, with the exception that the season of use for livestock watering season that was enlarged by the Settlement Agreement and constitutes an impermissible amendment as described in Finding 22, above; the season of use for livestock watering recognized herein is consistent the Claimant's original claim.

- 2. The GENERAL CONCLUSIONS OF LAW CONCERNING AMENDMENT OF CLAIMS is incorporated as if set forth fully herein.
- 3. Because there is no evidence on the record to the contrary, the standard rate of 12 gallons of water per head of livestock per day, measured at the place of use, as outlined in the GENERAL FINDINGS OF FACT of the FINAL ORDER OF DETERMINATION will apply.
- 4. Because there is no evidence on the record to the contrary, the standard duty for irrigation, being 3.5 acre-feet per acre, and the standard rate for irrigation, being 1/40 of one cubic foot per second per acre, as outlined in the GENERAL FINDINGS OF FACT of the FINAL ORDER OF DETERMINATION will apply.
- 5. Based on the file and record herein, IT IS ORDERED that Claim 731 is approved as set forth in the following Water Right Claim Description.
