The GENERAL FINDINGS OF FACT of the FINAL ORDER OF DETERMINATION is incorporated as if set forth fully herein.

A. FINDINGS OF FACT

- 1. On April 29, 1997, the UNITED STATES DEPARTMENT OF AGRICULTURE, FOREST SERVICE (USFS) timely submitted a Statement and Proof of Claim (Claim 378) to the Oregon Water Resources Department (OWRD) pursuant to ORS Chapter 539 in the Klamath Basin Adjudication claiming a federal reserved water right under the Organic Administration Act of 1897, 16 U.S.C. §§ 473-475, 477-482 and 551 (Organic Act), and under the Multiple-Use Sustained-Yield Act of 1960, 16 U.S.C. §§ 528-531(MUSYA).
- 2. On October 4, 1999, following investigation of the evidence submitted, the Adjudicator issued a Summary and Preliminary Evaluation of Claims (Preliminary Evaluation) stating the portion of the claim under the Organic Act was approved and the portion of the claim under MUSYA was denied.
- 3. On May 5, 2000, the Claimant, USFS, timely filed Contest 2071 to the Preliminary Evaluation of Claim 378.
- 4. On May 1, 2000, William J. Rust and Ethel J. Rust timely filed Contest 50 to the Claim and/or Preliminary Evaluation of Claim 378.
- 5. On May 1, 2000, Leonard Baio timely filed Contest 284 to the Claim and/or Preliminary Evaluation of Claim 378.
- 6. On May 2, 2000, Gary Strong timely filed Contest 519 to the Claim and/or Preliminary Evaluation of Claim 378.

- 18. On May 8, 2000, Thomas H. Bentley timely filed Contest 5190 to the Claim and/or Preliminary Evaluation of Claim 378.
- 19. On May 8, 2000, Thomas E. Stephens timely filed Contest 5423 to the Claim and/or Preliminary Evaluation of Claim 378.
- 20. On May 8, 2000, the following parties, hereinafter collectively referred to as the "Klamath Project Water Users," filed Contest 3669: Klamath Irrigation District, Klamath Drainage District, Tulelake Irrigation District, Klamath Basin Improvement District, Ady District Improvement Company, Enterprise Irrigation District, Klamath Hills District Improvement Co., Malin Irrigation District, Midland District Improvement Company, Pine Grove Irrigation District, Pioneer District Improvement Company, Poe Valley Improvement District, Shasta View Irrigation District, Sunnyside Irrigation District, Don

- Johnston & Son, Modoc Lumber Co., Bradley S. Luscombe, Berlva Pritchard¹, Don Vincent², Randy Walthall, Inter-County Title Co., Winema Hunting Lodge, Inc., Van Brimmer Ditch Co., Plevna District Improvement Co., and Collins Products, LLC.
- 21. These matters were referred to the Office of Administrative Hearings for a contested case hearing. The Office of Administrative Hearings designated these matters and other like claims of the USFS as Case 007.
- 22. On July 2, 2002, the following contestants withdrew with prejudice their respective contest: Leonard Baio, Gary Strong, Flynn Brothers, Robert Bartell, Margaret Jacobs, Carolyn Obenchain, Rodney Z. James, Newman Enterprise (Douglas Newman), Francis Loving Trust, Hilda Francis Trustee, John Briggs, Peter M. Bourdet, Vincent Lee Briggs, Thomas William Mallams, Thomas H. Bentley, Thomas E. Stephens, and David Cowan, successor in interest to William J. Rust and Ethel J. Rust. *See* NOTICE OF WITHDRAWAL OF BAIO *ET AL'S* CONTESTS AGAINST THE UNITED STATES FOREST SERVICE CLAIMS (July 2, 2002).
- 23. On December 26, 2002, the Klamath Project Water Users withdrew with prejudice Contest 3669. See WITHDRAWAL OF KLAMATH PROJECT WATER USER'S CONTESTS AGAINST THE UNITED STATES FOREST SERVICE CLAIMS (Dec. 26, 2002).
- On December 30, 2002, the USFS amended Claim 378 by reducing the claim as follows: The "[p]ortion of this claim based on the Multiple Use Sustained Yield Act of June 12, 1960, 16 U.S.C. 528 et seq. is deleted," and the rate was reduced "from 14.953 cfs as originally claimed, to 13.766 cfs."
- 25. On March 11, 2003, the Claimant, USFS, withdrew with prejudice Contest 2071, the remaining contest to Claim 378. *See* UNITED STATES NOTICE OF WITHDRAWAL OF CONTESTS (Mar. 11, 2003).
- 26. On April 2, 2003, the Adjudicator withdrew Case 007 from the Office of Administrative Hearings.
- 27. The place of use underlying Claim 378 is within a federal reservation of land that is owned by the Claimant.
- As explained in the GENERAL CONCLUSIONS OF LAW CONCERNING CLAIMS BASED ON THE ORGANIC ADMINISTRATION ACT OF 1897, the date of reservation is the priority date of a federal reserved water right. This claim contains four reservation dates as follows: (1) the reservation date of September 17, 1906 is based on the Presidential Proclamation of September 17, 1906, (2) the reservation date of May 14, 1930 is based on the Act of May 14, 1930, P.L. No. 214, 46 Stat.278 (1930), (3) the reservation date of April 15,

1961 is based on the "Proclamation Taking Title to Certain Lands. . ." April 15, 1961, Federal Register, 26 Fed. Reg. 3251-3254 (1961), and (4) the reservation date of November 15, 1974 is based on a Declaration of Taking, November 15, 1974, Civil No. 74-894, U.S. District Court of Oregon. The priority date applicable to each aspect of the claim is set forth in the Water Right Claim Description below.

29. The rate, maximum acre-feet per year allowed, and season of use claimed, as amended by the USFS on December 30, 2002, are no more than necessary to fulfill the primary purposes of the reservation.

B. DETERMINATION

- 1. The Organic Administration Act of 1897 for a federal reserved water right is a valid basis for this claim, including the claimed purposes of use. The GENERAL CONCLUSIONS OF LAW CONCERNING CLAIMS BASED ON THE ORGANIC ADMINISTRATION ACT OF 1897 is incorporated as if set forth fully herein.
- 2. Based on the file and record herein, IT IS ORDERED that Claim 378 is approved as amended by the USFS and as set forth in the following Water Right Claim Description.
