You visited the office yesterday and verbally requested an extension of time for complete application of water under Permit No. 6627. It is stated that conditions were very much the same a year ago as they are now and the only reason that you have been unable to irrigate the entire ten acres is that insufficient water was available.

NOTICE OF COMPLETION OF CONSTRUCTION

I, M. M.
