FINAL ORDER

Appeal Rights

This is a Final Order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This statement of judicial review rights does not create a right to judicial review of this order, if judicial review is otherwise precluded by law. Where no changes have been made to a Proposed Final Order on a water right application and no protests have been filed during the protest period, the Final Order is not subject to judicial review.

Application History

On April 13, 2012, John M. Lipkowitz submitted an application to the Department for a water use permit. The Department issued a Proposed Final Order on April 23, 2013. The protest period closed June 7, 2013, and no protest was filed.

On May 6, 2013 the application was assigned to John M. Lipkowitz and Kerri Borman Family Trust.

As required by OAR 690-505-0615, the applicant must submit proposed mitigation that meets the requirements of OAR 690-505-0610(2)-(5). Pursuant to OAR 690-505-0620, a permit shall not be issued until the applicant provides documentary evidence that mitigation water, in an amount satisfying the mitigation obligation, is legally protected instream.

On April 29, 2013, the applicant provided documentary evidence that 2.7 mitigation credits have been obtained from the Deschutes River Conservancy Mitigation Bank. The mitigation credits obtained by the applicant were generated from Mitigation Project MP-144, which are based on an instream lease that generated temporary mitigation credits. These credits are valid through December 31, 2015. The submission of documentary evidence that 2.7 acre-feet of satisfactory mitigation meets the requirements of OAR 690-505-0610(2)-(5) within the Little Deschutes Zone of Impact.

Conclusions of Law

The proposed use would not impair or be detrimental to the public interest (ORS 537.621(2)), but the Department's continuing evaluation reveals that the Proposed Final Order requires modification to correctly describe the proposed use to include the surface area of the pond (ORS 537.625(1)).

Order

Application G-17553 therefore is approved as proposed by the Proposed Final Order and Permit G-17060 is issued due to submission of documentary evidence that 2.7 mitigation credits within the Little Deschutes Zone of Impact have been obtained.
