**Application History**

Permit G-14036 was issued by the Department on July 20, 2001. The permit called for complete application of water to beneficial use by October 1, 2005. On April 5, 2012, Krupa Laxmi, Inc. submitted to the Department an Application for Extension of Time for Permit G-14036. In accordance with OAR 690-315-0050(2), on May 28, 2013, the Department issued a Proposed Final Order proposing to extend the time to fully apply water to beneficial use to October 1, 2015. The protest period closed July 12, 2013, in accordance with OAR 690-315-0060(1). No protest was filed.

**Appeal Rights**

This is a final order in other than a contested case. This order is subject to judicial review under ORS 183.484. A request for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either file for judicial review, or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

**Findings of Fact**

The Department adopts and incorporates by reference the findings of fact in the Proposed Final Order dated May 28, 2013.

At time of issuance of the Proposed Final Order the Department concluded that, based on the factors demonstrated by the applicant, any comments received, and information within the file, the permit may be extended subject to no additional conditions.


**CONCLUSION OF LAW**

The applicant has demonstrated good cause for the permit extension pursuant to ORS 537.630, 539.010(5) and OAR 690-315-0040(2).

**Order**

The extension of time for Application G-15191, Permit G-14036, therefore, is approved. The deadline for applying water to full beneficial use within the terms and conditions of the permit is extended from October 1, 2005 to October 1, 2015.
