Application History

Permit G-15736 was issued by the Department on September 30, 2004. The permit called for complete application of water to beneficial use by October 1, 2008. On September 6, 2012, Halsey Resources, LLC., submitted to the Department an Application for Extension of Time for Permit G-15736. In accordance with OAR 690-315-0050(2), on June 18, 2013, the Department issued a Proposed Final Order proposing to extend the time to complete construction and to fully

apply water to beneficial use to October 1, 2017. The protest period closed August 2, 2013, in accordance with OAR 690-315-0060(1). No protest was filed.

Findings of Fact

The Department adopts and incorporates by reference the findings of fact in the Proposed Final Order dated June 18, 2013, with the following modifications to correct for scriver's errors:

Permit number G-15735, is corrected to reflect Permit number G-15736.

At time of issuance of the Proposed Final Order the Department concluded that, based on the factors demonstrated by the applicant, any comments received, and information within the file, the permit may be extended subject to no additional conditions.

This Superseding Final Order replaces the Final Order dated August 18, 2013, which is now cancelled, and no longer in effect.

CONCLUSION OF LAW

The applicant has demonstrated good cause for the permit extension pursuant to ORS 537.630, 539.010(5) and OAR 690-315-0040(2).

<u>Order</u>

The extension of time for Application G-16139, Permit G-15736, therefore, is approved. The deadline for completing construction and for applying water to full beneficial use within the terms and conditions of the permit is extended from October 1, 2008 to October 1, 2017.
