Superseding Final Order

Hearing and Appeal Rights

Under the provisions of ORS 537.170 and ORS 537.622, the applicant may request a contested case hearing by submitting the information required for a protest under ORS 537.153(6) or ORS 537.621(7) to the Department within 14 days after the date of mailing of this order as shown below. If a contested case hearing is requested, the Department must schedule one. In the contested case hearing, however, only those issues based on the modifications to the Proposed Final Order may be addressed.

ORS 536.075 allows for additional appeal rights for other than contested case. This is a Final Order in other than contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60 day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080 you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

This statement of judicial review rights does not create a right to judicial review of this order, if judicial review is otherwise precluded by law. Where no changes have been made to a Proposed Final Order on a water right application and no protests have been filed during the protest period, the Final Order is not subject to judicial review.

Application History

On August 22, 2011, Pacific Motorsports Management, LLC submitted an application to the Department for a water use permit. The Department issued a Proposed Final Order on February 28, 2012. The protest period closed April 13, 2012, and no protest was filed.

On May 3, 2012, the Department issued a Final Order and draft permit approving the application contingent upon the submission of evidence documenting compliance with current minimum well construction standards for Well 2 (SHER 50279).

On August 3, 2013, the applicant submitted a Water Supply Well Report of the replacement well, which was assigned SHER 50362. The applicant also submitted a Water Supply Well Report for the abandonment of Well 2 (SHER 50279), which was assigned SHER 50361.

On August 15, 2013, the applicant provided a revised application map showing the new location of Well 2 (SHER 50362).

On September 5, 2013, the Department reviewed the Water Supply Well Report for Well 2 (SHER 50362), and determined that the well meets current minimum well construction standards. In addition, the Department reviewed the Well Report for SHER 50361 and determined that it was properly abandoned.

On September 5, 2013, the Department reviewed the Well Report for Well 2 (SHER 50362) and determined that it develops the same aguifer as the abandoned Well 2 (SHER 50361).

The proposed use would not impair or be detrimental to the public interest, but the Department's continuing evaluation reveals that the Proposed Final Order requires modification to describe the well location of Well 2 (SHER 50362).

This order supersedes the May 3, 2013 Final Order for Application G-17484, which is of no further force or effect.

Order

This order supersedes the May 3, 2013 Final Order for Application G-17484, which is of no further force or effect.

Application G-17484 therefore is approved with the above modifications to the Proposed Final Order, and Permit G-17083 is issued as limited by the conditions set forth therein.
