A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

## <u>Application History</u>

Permit G-15068 was issued by the Department on May 24, 2002. The permit called for completion of construction and complete application of water to beneficial use by October 1, 2006. On January 22, 2013, G I Ranch Corp., Willaim L. Smith submitted to the Department an Application for Extension of Time for Permit G-15068. In accordance with OAR 690-315-0050(2), on August 13, 2013, the Department issued a Proposed Final Order proposing to extend the time to complete construction and to fully apply water to beneficial use to October 1, 2014.

The protest period closed September 27, 2013, in accordance with OAR 690-315-0060(1). No protest was filed.

## Findings of Fact

The Department adopts and incorporates by reference the findings of fact in the Proposed Final Order dated August 13, 2013.

#### **CONCLUSION OF LAW**

The applicant has demonstrated good cause for the permit extension pursuant to ORS 537.630, 539.010(5) and OAR 690-315-0040(2).

## <u>Order</u>

The extension of time for Application G-15223, Permit G-15068, therefore, is approved. The deadline for completing construction and applying water to full beneficial use within the terms and conditions of the permit is extended from October 1, 2006 to October 1, 2014.
