Permit S-54129 was issued by the Department on September 30, 2004. The permit called for complete application of water to beneficial use by October 1, 2008. On June 17, 2013 Howard and Judy Pope Trust submitted to the Department an Application for Extension of Time for Permit S-54129. In accordance with OAR 690-315-0050(2), on August 6, 2013, the Department issued a Proposed Final Order proposing to extend the time to complete construction and to

Appeal Rights

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

apply water to full beneficial use to October 1, 2018. The protest period closed September 20, 2013, in accordance with OAR 690-315-0060(1). No protest was filed.

The Department adopts and incorporates by reference the findings in the Proposed Final Order dated August 6, 2013.


CONCLUSION OF LAW
