Permit S-54125 was issued by the Department on September 30, 2004. The permit called for complete application of water to beneficial use by October 1, 2008. On June 17, 2013, Jenks Olsen Farms, Inc. submitted to the Department an Application for Extension of Time for Permit S-54125. In accordance with OAR 690-315-0050(2), on August 6, 2013, the Department issued a Proposed Final Order proposing to extend the time to complete construction and to apply water

Appeal Rights

A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.

to full beneficial use to October 1, 2018. The protest period closed September 20, 2013, in accordance with OAR 690-315-0060(1). No protest was filed.

Findings of Fact

The Department adopts and incorporates by reference the findings in the Proposed Final Order dated August 6, 2013.

CONCLUSION OF LAW

The applicant has demonstrated good cause for the permit extension pursuant to ORS 537.230, 539.010(5) and OAR 690-315-0040(2).

<u>Order</u>

The extension of time for Application S-85917, Permit S-54125, therefore, is approved. The deadline for completion of construction and for applying water to full beneficial use within the terms and conditions of the permit is extended from October 1, 2008 to October 1, 2018.
