Authority

ORS 537.147 establishes the process by which an application to use stored water exclusively may be submitted. OAR Chapter 690, Divisions 310 and 340 implement the statute, and provide the Department's procedures and criteria for evaluating applications to use stored water exclusively.

Findings of Fact

- 1. On May 28, 2013, RIVER BEND WEST IRRIGATION ASSOCIATION submitted an application for a water-use permit pursuant to ORS 537.147. The Department provided public notice of the application in the Department's weekly public notice on June 18, 2013. A 30-day comment period followed.
- 2. The Department has evaluated the application and any comments received, and finds that no public interest in ORS 537.170(8) would be affected adversely by the proposed use.
- 3. The area proposed to be irrigated under this application is currently covered by an existing surface water irrigation right Permit S-54411 (Application S-86903). The Department understands you will concurrently cancel Permit S-54411, which is located in Section 13, Township 26 South, Range 7 West, W.M., upon issuance of a permit for this application.

Conclusions of Law

Application S-87902 is consistent with the requirements of ORS 537.147, and OAR Chapter 690.

Now Therefore, it is Ordered:

Application S-87902 is approved, and Permit Number S-54859 is issued as limited by the conditions contained therein.
