CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

SANTIAM WATER CONTROL DISTRICT
284 E WATER ST
STAYTON OR 97383

confirms the right to use the waters of DETROIT RESERVOIR CONSTRUCTED UNDER PERMIT R-1625, a tributary of the NORTH SANTIAM RIVER, for SUPPLEMENTAL IRRIGATION OF 398.42 ACRES.

This right was perfected under Permit S-51318. The date of priority is April 10, 1987. The amount of water to which this right is entitled is limited to an amount actually used beneficially, and shall not exceed 997.5 ACRE-FEET STORED WATER ONLY or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

The amount of water used for irrigation under this right, together with the amount secured under any other right existing for the same lands, is limited to a diversion of 2.5 acre-feet for each acre irrigated during the irrigation season of each year. This right is limited to any deficiency in the available supply of any prior right existing for the same land.

The water user shall comply with the terms and conditions of contract 7-07-10-W0675 between Santiam Water Control District and Bureau of Reclamation. A copy of the contract is in Application File S-69055 at the Water Resources Department.

NOTICE OF RIGHT TO PETITION FOR RECONSIDERATION OR JUDICIAL REVIEW

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may either petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied. In addition, under ORS 537.260 any person with an application, permit or water right certificate subsequent in priority may jointly or severally contest the issuance of the certificate at any time before it has issued, and after the time has expired for the completion of the appropriation under the permit, or within three months after issuance of the certificate.
