Authority

ORS 537.147 establishes the process by which an application to use stored water exclusively may be submitted. OAR Chapter 690, Divisions 310 and 340 implement the statute, and provide the Department's procedures and criteria for evaluating applications to use stored water exclusively.

Findings of Fact

- 1. On July 9, 2008, Greenberry Irrigation District submitted an application for a water-use permit pursuant to ORS 537.147.
- 2. The Department provided public notice of the application in the Department's weekly public notice on September 9, 2008. A 30-day comment period followed.
- 3. The Department has evaluated the application and any comments received, and finds that no public interest in ORS 537.170(8) would be affected adversely by the proposed use.
- 4. On April 3, 2009, the Department issued a Final Order approving the application contingent upon the submission of a voluntary cancellation request of Permits S-53779 and S-83780.
- 5. On January 21, 2010, the Department issued Orders canceling Permits S-53779 and S-83780.
- 6. In January 2010, the Department received additional information clarifying the points of diversion and place of use.
- 7. This document supersedes the April 3, 2009 Final Order for Application S-87220, which is of no further force or effect.

Conclusions of Law

Application S-87220 is consistent with the requirements of ORS 537.147, and OAR Chapter 690.

Now Therefore, it is Ordered:

This document supersedes the April 3, 2009 Final Order for Application S-87220, which is of no further force or effect.

Application S-87220 is approved, and Permit Number S-54576 is issued as limited by the conditions contained therein.

This is an order in other than a contested case. This order is subject to judicial review under ORS 183.484. Any petition for judicial review must be filed within the 60-day time period specified by ORS 183.484(2). Pursuant to ORS 536.075 and OAR 137-004-0080, you may petition for judicial review or petition the Director for reconsideration of this order. A petition for reconsideration may be granted or denied by the Director, and if no action is taken within 60 days following the date the petition was filed, the petition shall be deemed denied.
